

NARRATIVE

This partition was done at the request of Brad Allen, on behalf of Allen Potato LLC. Mr. Allen wanted to divide the property as shown. City of Haines was placed by Survey Number 7-39-94. I recover monuments at the NE corner of Block 9 and the Southwest corner of Block 3, and place the centerlines of School Street, Sixth Street and the SE corner of Block 10 as per said Survey. The remaining Parcel 3 is UNSURVEYED. Monuments shown along the exteriors are of record only, shown for informational purposes. No attempt was made to locate these on the ground. I find no other unusual conditions with this partition.

The Centerline of Fifth Street being South 62°42'47" West, as per Baker County Survey Numbers 7-39-10, 7-39-22 and 7-39-23
