NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO PARTITION LAND DESCRIBED IN DEED 89 05 075-078 INTO THREE PARCELS. NUMEROUS ADJOINING TRACTS ALONG SPRING GARDEN AVENUE AND ELM STREET AS DESCRIBED IN THEIR RESPECTIVE DEEDS ARE BASED ON DIFFERING MERIDIANS. FOR THE PURPOSE OF THIS SURVEY THE SURVEYOR'S CERTIFICATE FOR VISTA HEIGHTS ADDITION PLAT BY IRA L. HOFFMAN, FILED JUNE 11, 1912, CONTAINING REFERENCE TO SPRING GARDEN AVENUE BEARING S. 86°09'W. IS ADOPTED HEREIN FOR THIS PARTITION SURVEY. ADJOINING PROPERTY BOUNDARY BEARINGS ARE ROTATED ACCORDINGLY TO CONFORM TO THIS COMMON BASIS. ACCESS ROAD ALIGNMENT DATA DESCRIBES LOCATION OF CENTERLINE FOR 20 FEET WIDE ROAD EASEMENT.
