

SURVEYOR'S CERTIFICATE

I. James D. Hanley certify that I have platted the land represented on the annexed minor partition map dividing the tract owned by the partitioner into two parcels. No survey was made for

the purpose of plat preparation. Description of the partition follows:

NARRATIVE

The purpose of this plat for Jerald A. Cantrell is to partition the above described land into two parcels in accordance with ORS Chapter 92. The intent is to separate the land lying outside Old Oregon Trail Hwy 30 right of way and the Radium Hot Springs property into its aliquot parts, based on original survey by Thompson and Chaplin under GLO Contract No. 104 dated July 20, 1864. The use of term "approximately" acknowledges subsequent resurvey of the land is not expected to result exactly in the GLO plat distances. GLO bearings/distances are shown in parentheses. Radium Hot Springs parcel bearings/distances are from Baker Co. Survey No. 7-39-1. For Hwy. information see O.S.H.D. Drawing IR-1-771.
