SURVEYOR'S CERTIFICATE

I, James D. Hanley certify that I have correctly surveyed and prepared this minor partition plat in accordance with O.R.S. Chapter 92. The land partition is described as follows: In the SW1/4NW1/4 Section 15, Township 9 South, Range 40 East, Willamette Meridian: Beginning at a point on the South line of the said SW1/4NW1/4 and on the Easterly right of way line of U.S. Highway 1-84, which bears N. 88° 15' 18" E., 37.13 feet from the SW corner of the said SW1/4NW1/4; thence following the said right of way line N. 0° 44' 54" E., 356.79 feet; N. 1° 25' 18" W., 228.11 feet to the southerly Baker Co. Atwood Road (Campbell Street Crossing) right of way line; thence following the said right of way line N. 57° 36' 23" E., 763.50 feet; N. 52° 32' 54" E., 424.38 feet; N. 18° 52' 34" E., 112.03 feet to the North line of the said SW1/4NW1/4; thence N. 88° 33' 53" E., along the said North line 231.02 feet to the Northeast corner of the said SW1/4NW1/4; thence S. 1° 46' 46" E., along the East line of the said SW1/4NW1/4 1325.06 feet to the Southeast corner thereof; thence S. 88° 15' 18" W., along the South line of the said SW1/4NW1/4 494.98 feet; thence N. 1° 41' 25" W., 208.00 feet; thence S. 88° 15' 18" W., 208.00 feet; thence N. 1° 41' 25" W., 47.42 feet; thence S. 88° 15' 18" W., 213.18 feet; thence N. 1° 41' 25" W., 39.60 feet; thence S. 88° 15' 18" W., 295.02 feet; thence S. 1° 41' 25" E., 295.02 feet to the South line of the said SW1/4NW1/4; thence S. 88° 15' 18" W., along said South line 78.38 feet to the point of beginning for this description; excepting therefrom Baker Co. Allen Lane Road.

NARRATIVE

The purpose of this plat for John and Janice Gyllenberg is to partition a parcel of ground into two separate parcels as shown hereon. Monumentation along U.S. Hwy 1-84 Easterly right of way, Campbell Street crossing, the Northwest corner and West quarter corner of Section 15 was recovered for survey of that portion requiring the establishment of monumentation for Parcel No. 1 of this partition. Reference is made to County Surveys 9-40-25BC, 9-40-54, and 9-40-303 and Minor Partition Plat No. 1990-003 for the subdivision of Section 15 into its aliquot parts. Basis of bearing conforms to those surveys, determined by traverse between the Northwest corner and West quarter corner of Section 15, which were based on O.S.H.D. location map of freeway access monumentation, Map No. 1A-21-12. Baker County Allen Lane Road is shown hereon as located by this survey. The boundaries of three rectangular shaped parcels lying along the South line of the said SW1/4NW1/4 are described in deed records "due" North, South, East and West, with the intent being to follow section or mid-section lines. Rotation of bearings is made to conform to the true courses for purpose of this plat.

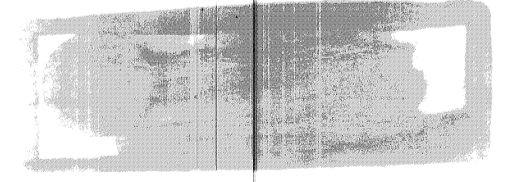

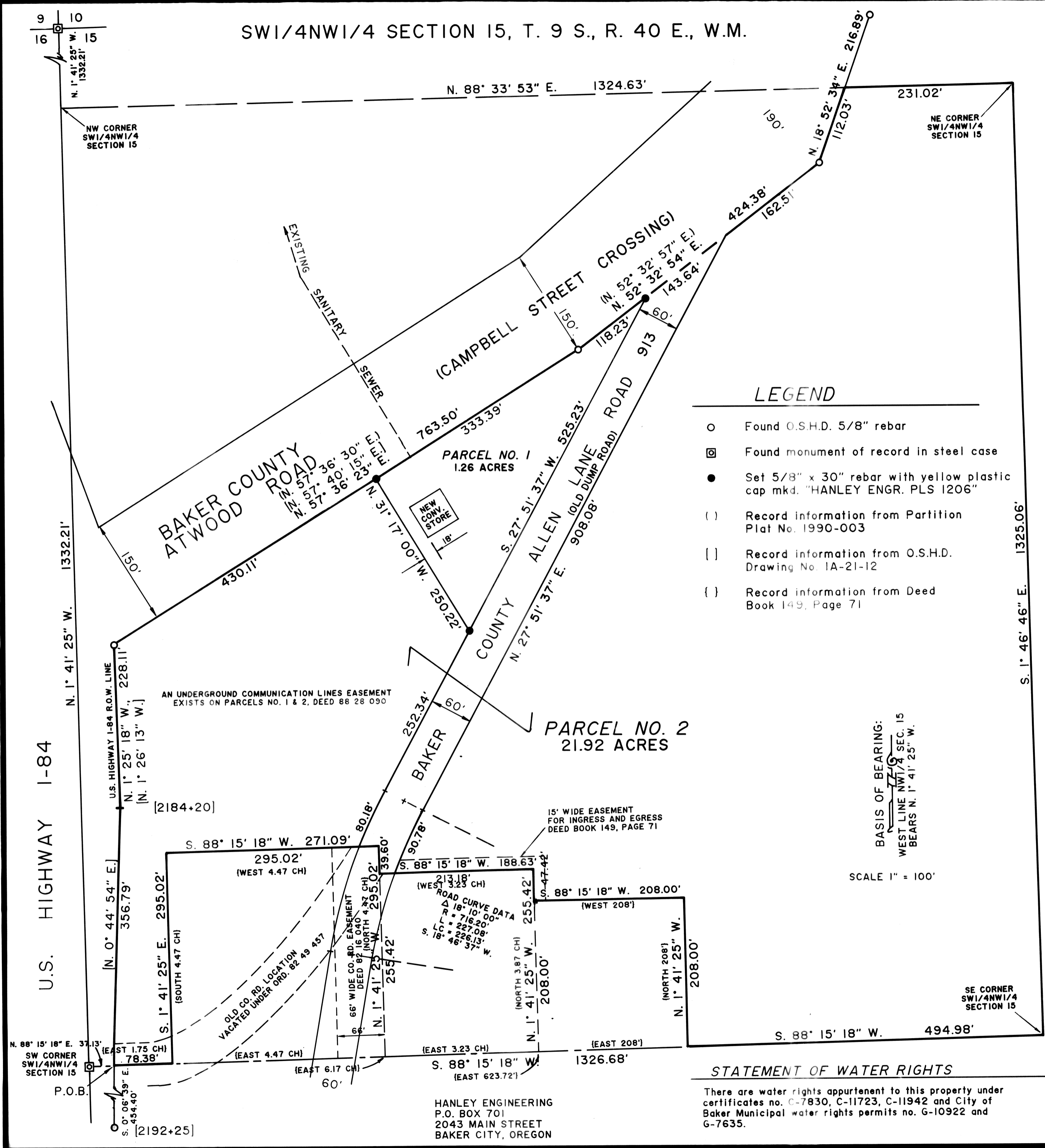
