Anderson of a portion of the old Baker-Cornucopia Highway, and other monumentation established by previous surveys. Interpretation of pertinent deed records determined intent, based on the above survey control. Monumentation recovery along the North line of Cedar Acres Subdivision (the South line of this partition) provided basis of conforming bearing of S. 89° 26' E. 
