



### SURVEYOR'S CERTIFICATE

I, James D. Hanley, hereby certify that I have correctly platted the lands represented on the annexed minor partition plat in accordance with O.R.S. Chapter 92. The boundary of the partition is described as follows: In the South half of the Northeast quarter of Section 34, T.7S., R. 38E., W.M.: Beginning at the Southwest corner of the SI/2 SWI/4 NEI/4 of said section; thence Northerly approximately 660 feet to the Northwest corner thereof; thence Easterly approximately 1320 feet to the Northeast corner thereof; thence Northerly along the West line of the SEI/4 NEI/4 approximately 60 feet to a point which is 601.26 feet Southerly of the Northwest corner thereof; thence approximately N.89°30'E., 414.5 feet; thence approximately N.88°35'E., 193.9 feet; thence Southerly approximately 347 feet along the West line of Rock Creek Avenue to the Northeast corner of Lot II, Block 2, Rock Creek Townsite; thence Westerly along the North line of Rock Creek Townsite approximately 400 feet to the Northeast corner of Lot 4, Block 2; thence Southerly along the East line of said Lot 4, Block 2, a distance of 10 feet; thence Westerly approximately 200 feet to a point on the West line Lot I, Block 2, which is 10 feet Southerly of the Northwest corner thereof; thence Southerly along the West line of Block I and 2, Rock Creek Townsite, 310 feet to the North line of Electric Street (Baker County Road No. 552); thence Southwesterly along the North line of County Road No. 552 approximately 400 feet to the South line of the said SI/2 SWI/4 NEI/4; thence Westerly approximately 920 feet to the point of beginning.

## NARRATIVE

The purpose of this plat for Michael K. Spry, Patricia J. Spry Marion Cooper and Darlene Gregory Cooper is to divide a tract of land into two parcels in accordance with O.R.S. Chapter 92. Parcel No. 1 is to contain 10.25 acres, Parcel No. 2 is to contain the remainder. No field survey was performed in preparation of this plat. An actual field survey of the subject property would result in different bearings, distances and total acres than those shown hereon. Boundary information shown was derived from G.L.O. data and Baker County Deed No. 88-45-104.
