SURVEYOR'S CERTIFICATE

I, James D. Hanley hereby certify that I have correctly surveyed and prepared this minor partition plat in accordance with O.R.S. Chapter 92. The land partition is as follows: A parcel of land in the North half of Gov't Lot 2 of the Southwest quarter Section 30, T. 8S., R. 39E., W.M., being Parcel No. 2 of Baker County Partition Plat P1990-011.

More particularly described as follows: Beginning at a point on the North line SW1/4 Section 30, which bears N.89° 48' 12" E. 859.75 feet from the Northwest corner of the North half Gov't Lot 2 of the Southwest quarter said Section 30 (West 1/4 corner Section 30); thence S.00° 18' 21" E., 1321.13 feet to the North right of way line Baker County Pine Creek Road No. 646; thence S.89° 57' 35" W. along said North right of way line 213.17 feet to the Northerly right of way line of the 40 foot wide Former Baker County Road; thence along the said Northerly right of way line the following courses: N.57° 28' 00" W., 75.92 feet, along a 592.96 foot radius curve left (the long chord of which bears N.62° 29' 39" W., 104.06') 104.20 feet; thence N.00° 18' 21" W., 1231.13 feet to the said North line SW1/4 Section 30; thence N.89° 48' 12" E. along said North line 369.00 feet to point of beginning.

NARRATIVE

This purpose of this survey and minor partition plat for Virgel L. and Doris A. Keithley and Kurt D. and Joan M. Hills is to divide the 11.0 acre property into two parcels as shown hereon. The subject property is Parcel No. 2 of Baker County Partition Plat No. P1990-011, recorded November 6, 1990 in Deed 90 45 072. The irregular shaped boundary between Parcels 1 and 2 of this partition is necessitated because of the location of the dwelling on Parcel No.1 and the 5 acre minimum area required for both parcels. Baker County road centerline data shown is from Meadowbrook West Subdivision plat. Monumentation along the West line Section 30 was recovered and held as the basis of bearing for this plat.

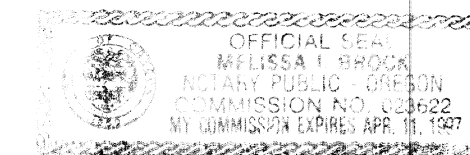

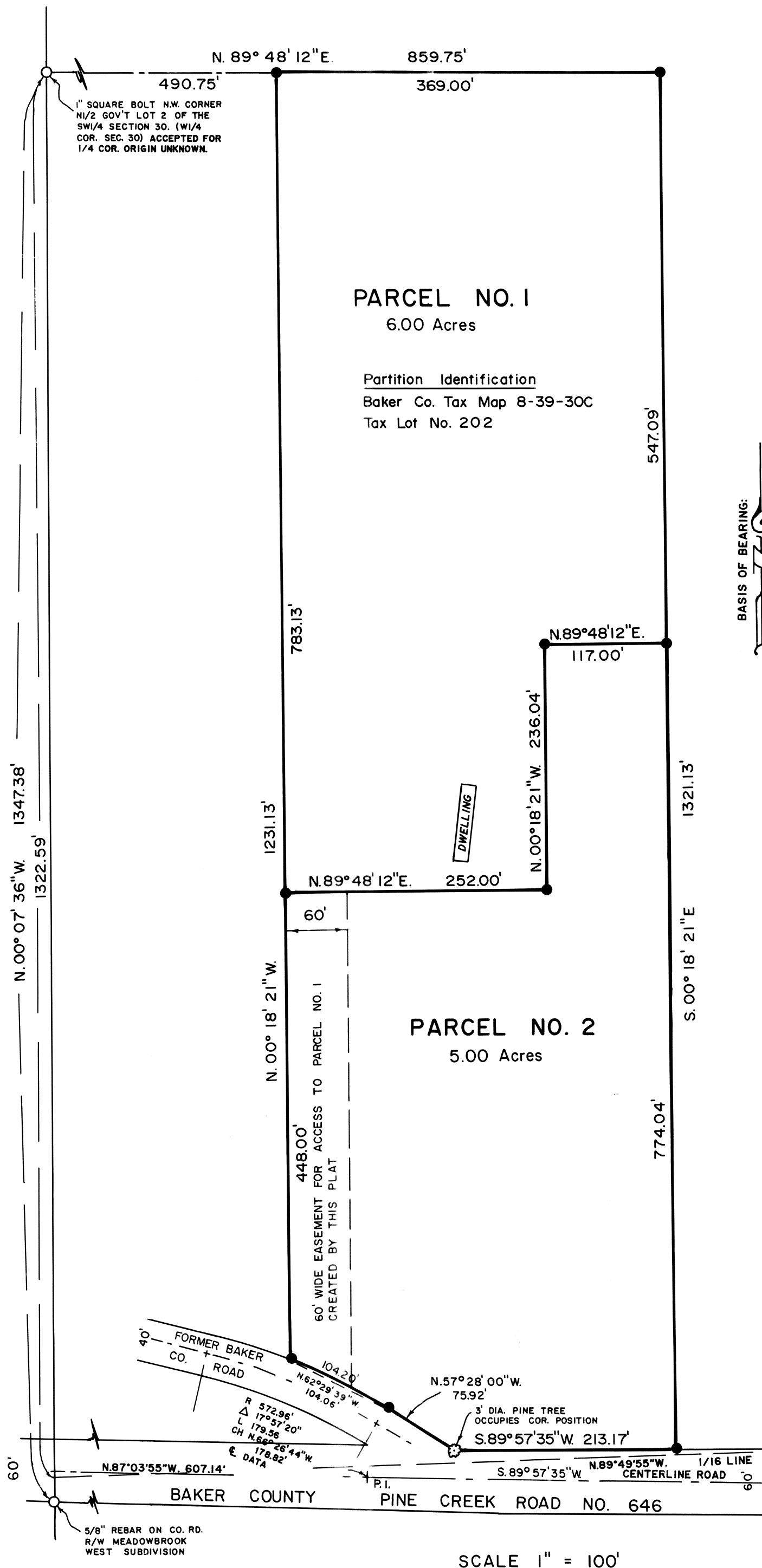

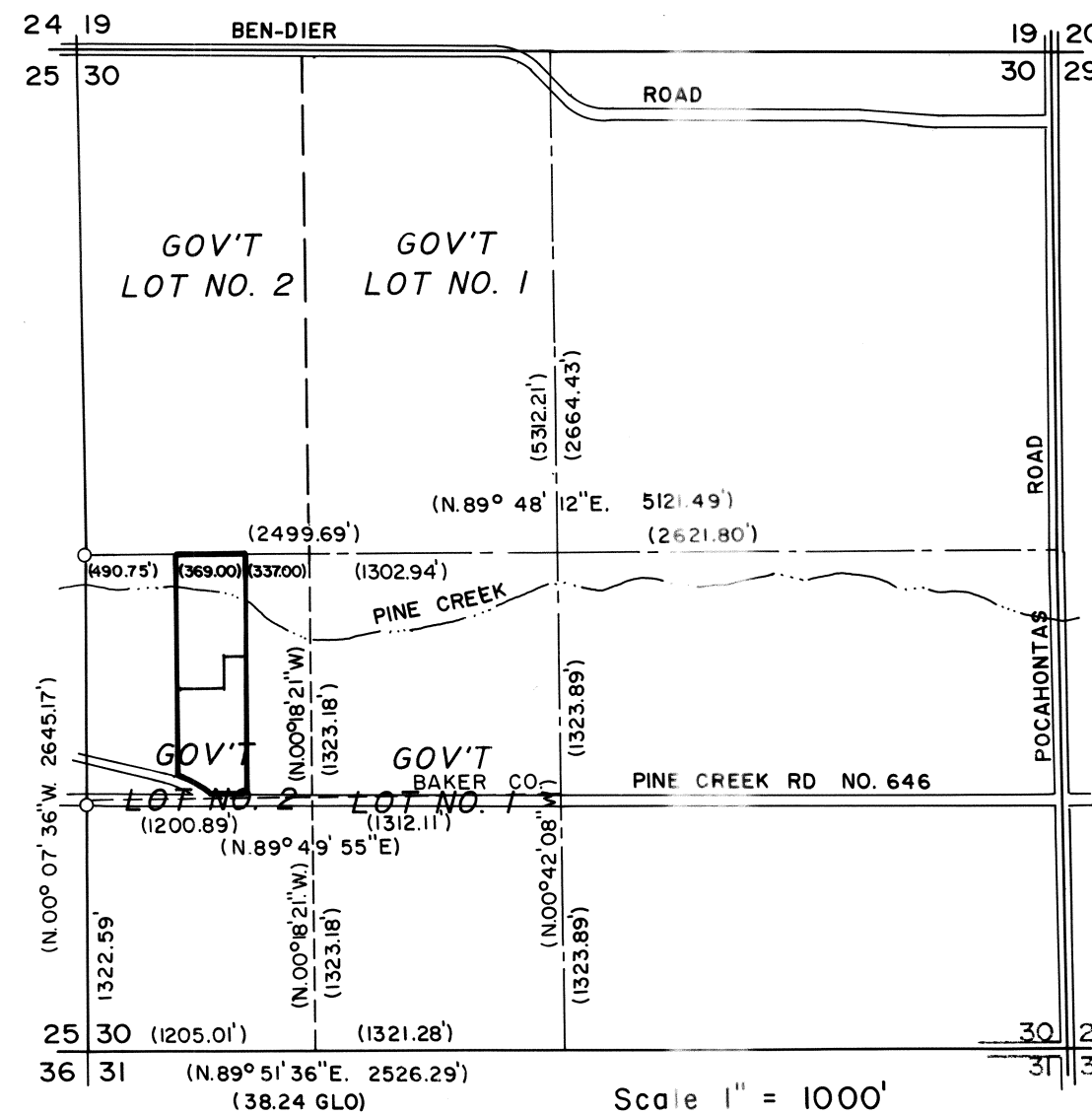
