

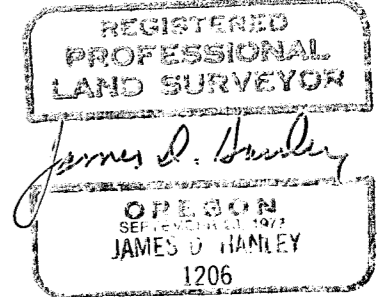
PROPERTY LINE ADJUSTMENT

SURVEYOR'S CERTIFICATE

I, James D. Hanley hereby certify that I have accurately surveyed and platted the area contained in the property line adjustment as indicated on the annexed map in conformance with Baker County zoning ordinance and O.R.S. Chapter 92. The description is as follows:
Land in the SW1/4NE1/4 of Section 8, T. 9 S., R. 40 E., W.M.:

Beginning at the Southeast corner of said Parcel No. 2 of Partition P 1996-002 at a point on the North right of way line of Hughes Lane, S. 89° 50' 50" W., 963.26 feet from the East quarter corner of the said Section 8; thence S. 88° 03' 47" W., 100.60 feet along the said right of way line; thence N. 03° E., 260.12 feet; thence S. 88° 03' 47" W., 54.27 feet; thence N. 03° W., 49.88 feet; thence N. 88° 03' 47" E., 154.87 feet to the Northeast corner of Parcel No. 2 of said partition; thence S. 03° E., 310.00 feet along the East line of said Parcel No. 2 of said partition to the point of beginning, encompassing 0.778 acre of land.

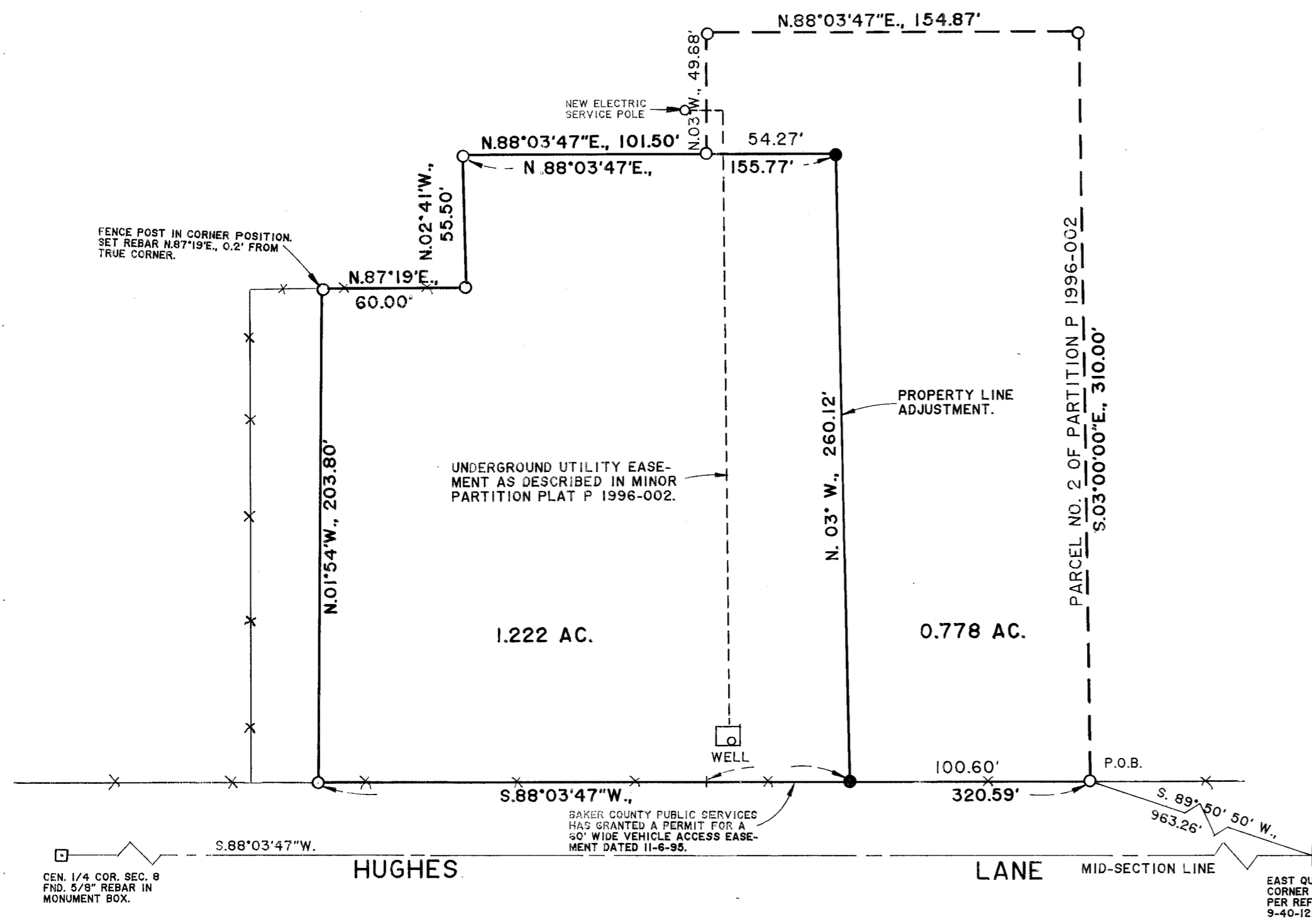

NARRATIVE

The purpose of this property line adjustment for James and Mary Ann Ingram is to reduce the area of land designated in Parcel No. 2 of Partition P 1996-002, from 2.00 acres to 1.222 acres and increase Parcel No. 1 of said partition from 147.93 acres to 148.708 acres. Corner monumentation for this partition was recovered and is basis of control for this additional survey. Bearings described in the said partition are held for this subject lot line adjustment.

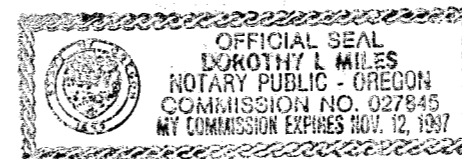
