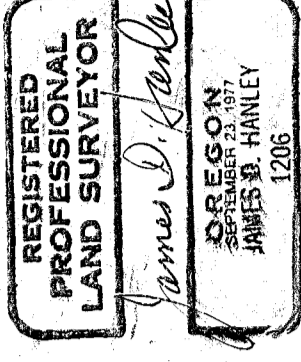

I James D. Hanley certify that I have correctly surveyed and platted three parcels of land on the annexed partition map in accordance with O.R.S. Chapter 92.060. A parcel in the SW1/4 NW1/4 of Section 8, T. 9 S., R. 40 E., W.M. being a repartition of Parcel No. 3 of M.P. # 1996-013. The repartition involves Parcel No. 3 of Partition Plat No. 1996-013. Commencing at the intersection of the North line of the said SW1/4 NW1/4 with the East right of way line of Baker County road containing Chico Street or Chico Street), N. 89° 53' E., 43.75 feet from the Northwest corner of the said SW1/4 NW1/4; thence S. 0° 41' 40" E., 202.43 feet along the said road line to the TRUE POINT OF BEGINNING, being the Northwest corner of Parcel No. 3 of Partition Plat No. 1996-013; thence N. 89° 53' E., 652.42 feet; thence S. 27° 09' 14" E., 261.97 feet; thence N. 89° 53' E., 451.28 feet to the Westerly right of way line of the Old Oregon Trail Highway U.S. 30; thence S. 27° 09' 14" E., 370.45 feet along said right of way line to the Southeast corner of said Parcel No. 3; thence S. 89° 53' W., 616.35 feet; thence N. 0° 41' 40" W., 94.75 feet; thence S. 89° 53' W., 652.42 feet to the Southwest corner of said Parcel No. 3 on the Easterly line at the country road; thence N. 0° 41' 40" W., a distance of 497.22 feet along the county road right of way line to the TRUE POINT OF BEGINNING.

This repartition contains 11.49 acres of land.

This repartition is configured and authorized at direction of the owners.

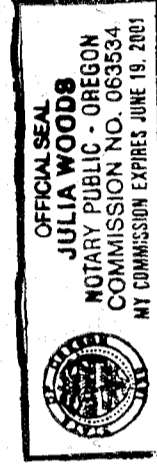

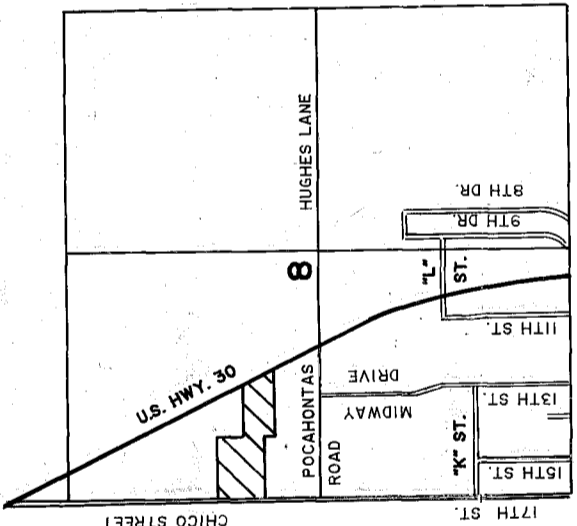

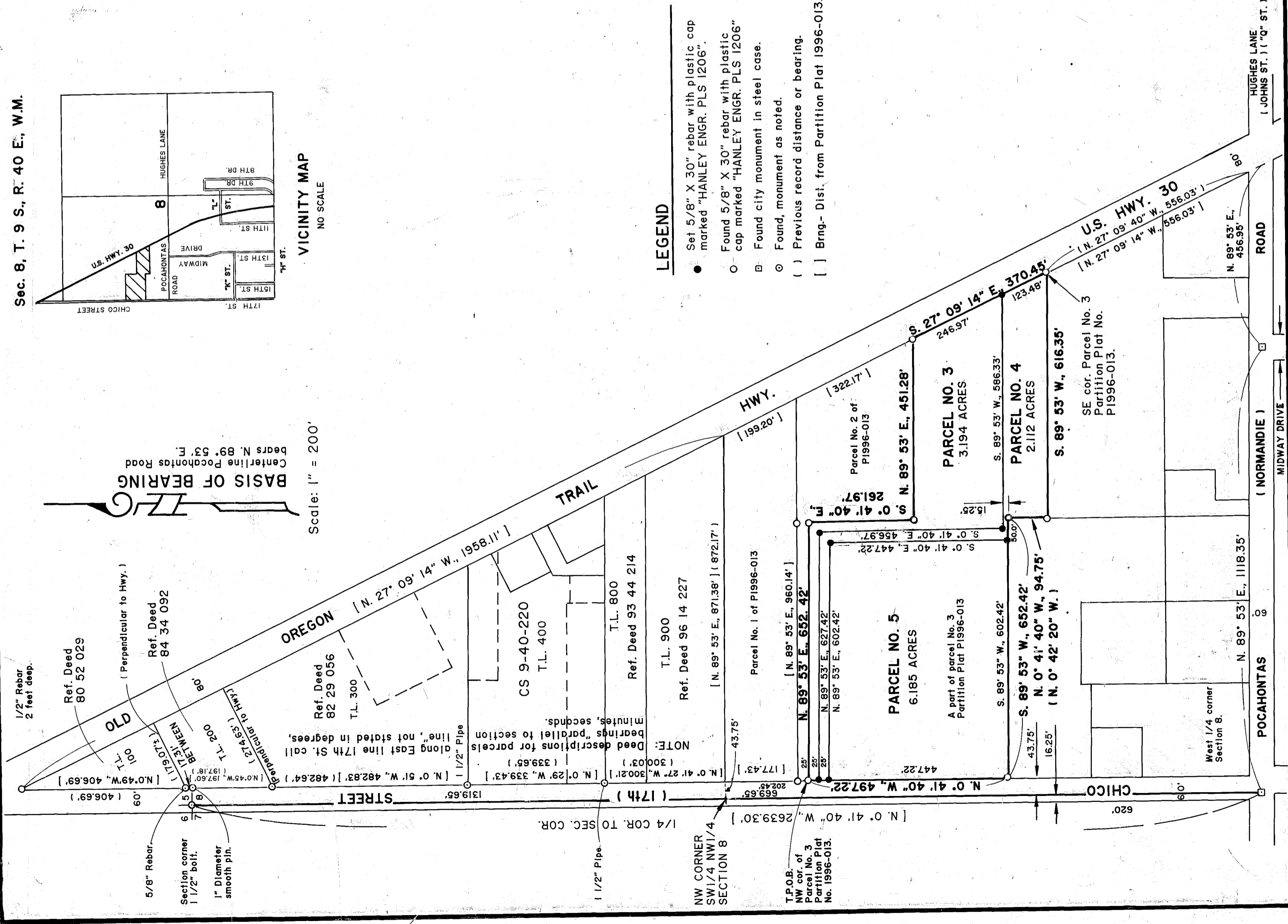
