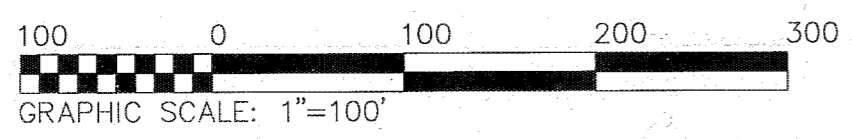
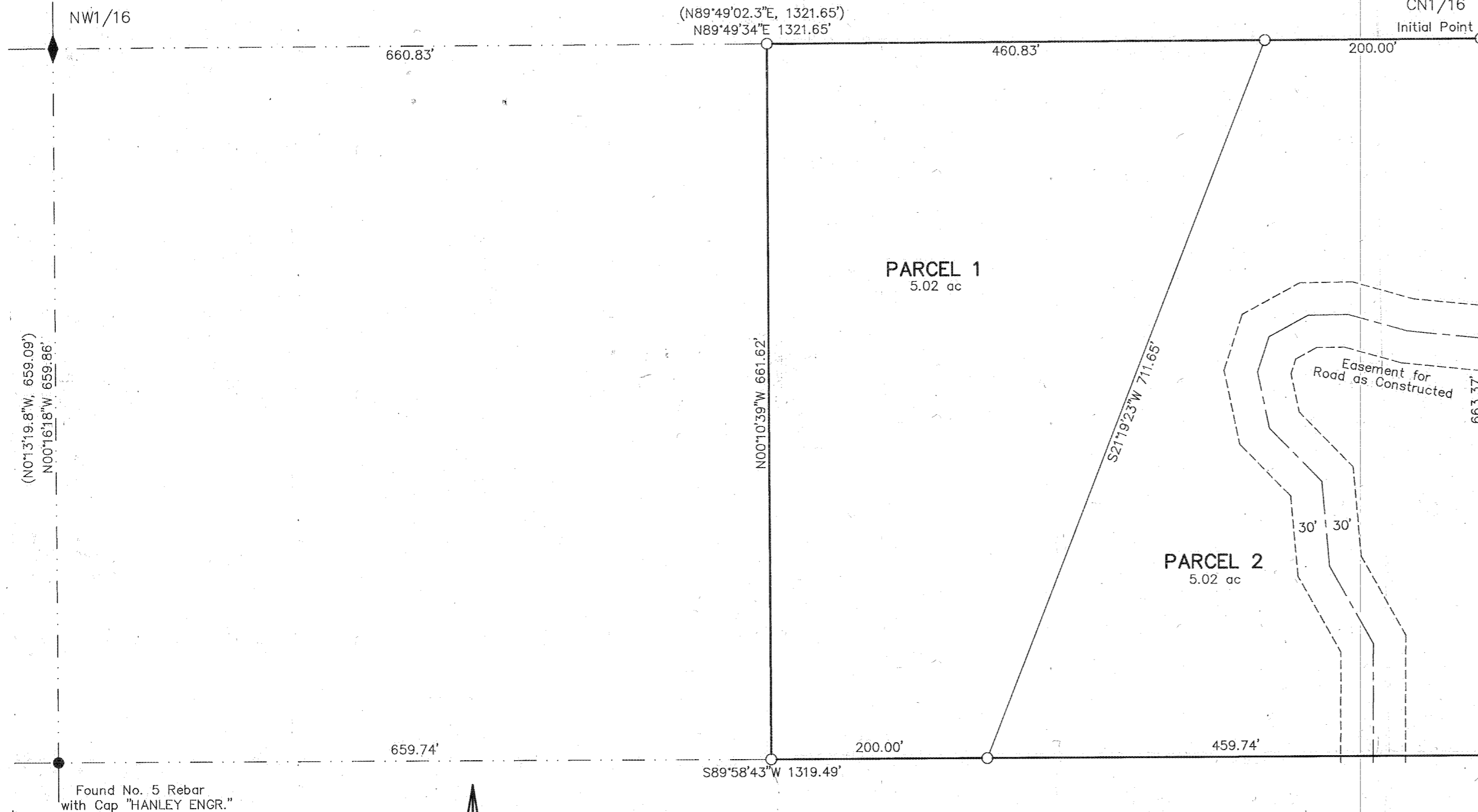


PARTITION PLAT No. P2000-006

NARRATIVE
 The purpose of this survey is to partition a ten acre parcel into two five acre parcels in the NE1/4SE1/4NW1/4 of Section 34, T9S, R37E, WM, Baker County, Oregon, at the request of Patsy McConkey.
 Section 34 was subdivided during several surveys, the last being a US Forest Service survey contract with Doug Ferguson recorded in 1992 as Baker County Map of Survey No. 9-37-181. I found my corresponding distances and bearings to be substantially the same as the Ferguson survey, therefore I did not resurvey the section to delineate the 10 acre aliquote part. No problems were found during this survey.
 There are a number (too numerous to list) of easement deeds for the purpose of ingress and egress and for installation of various utilities from the Baker County Cemetery Road to this property.
 The Basis for Bearings is Survey No. 9-37-181.
