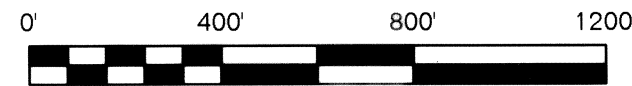
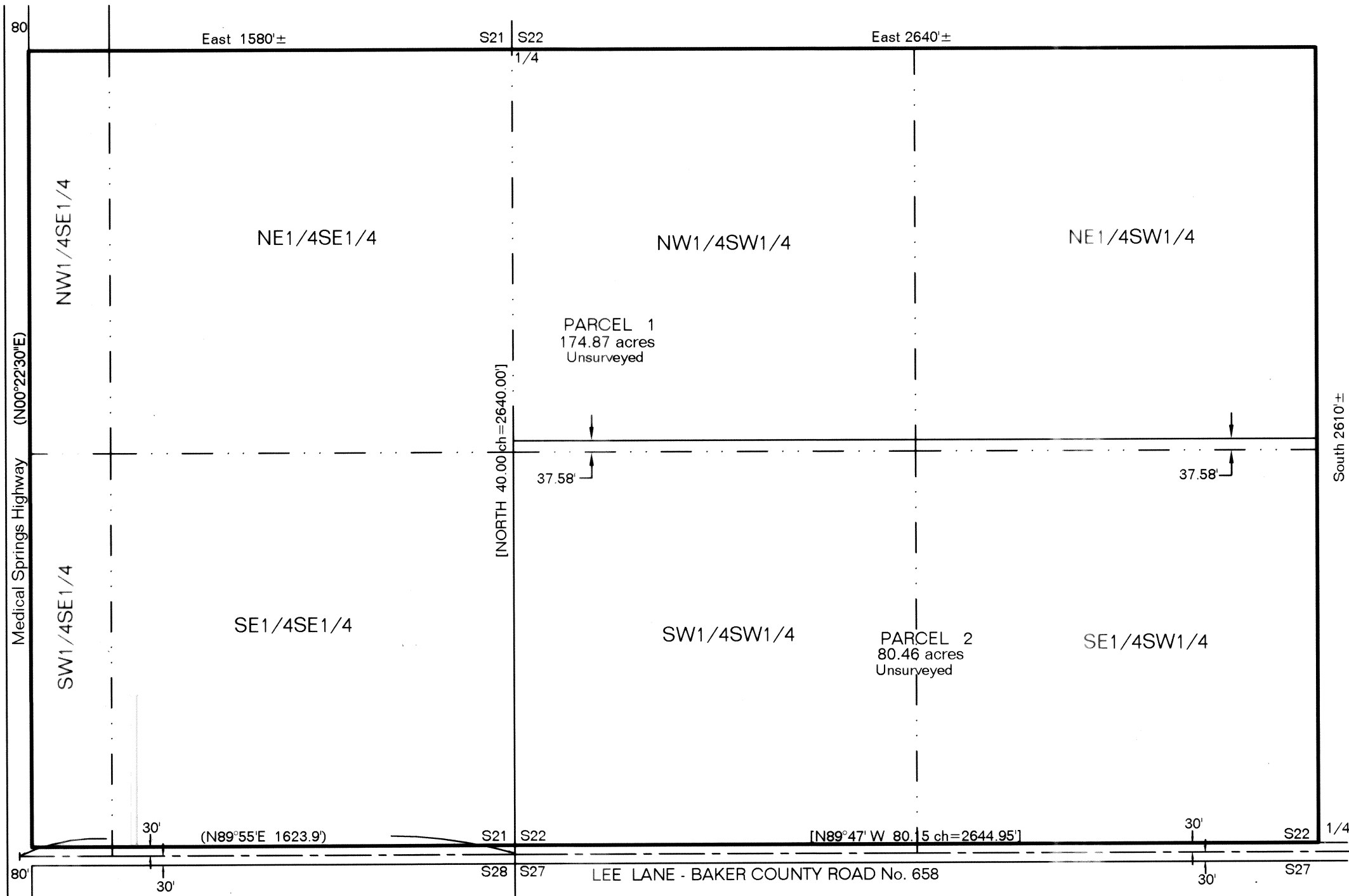


UNSURVEYED PARTITION PLAT No. P2006- 018

NARRATIVE

The purpose of this unsurveyed partition is to create two parcels of land in the SE1/4 of Section 21 and the SW1/4 of Section 22, T8S, R40E, WM, Baker County, Oregon, at the request of Beth Mackenzie.

There are no surveys of record in this area except the freeway and frontage roads. The dividing lines for the two parcels are controlled by aliquot parts of the sections.

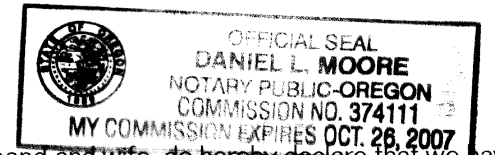

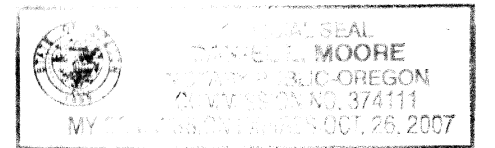
