Section 2: Lot 4, and that portion of Lot 3 and the Southeast quarter of the Northwest quarter lying Westerly of Denny Creek Road.

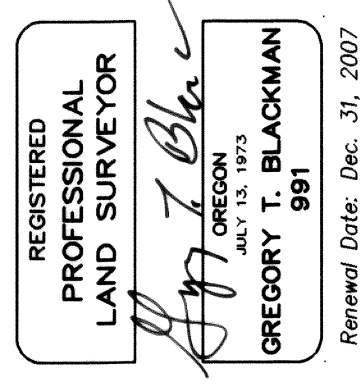

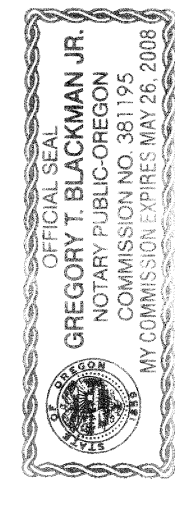
