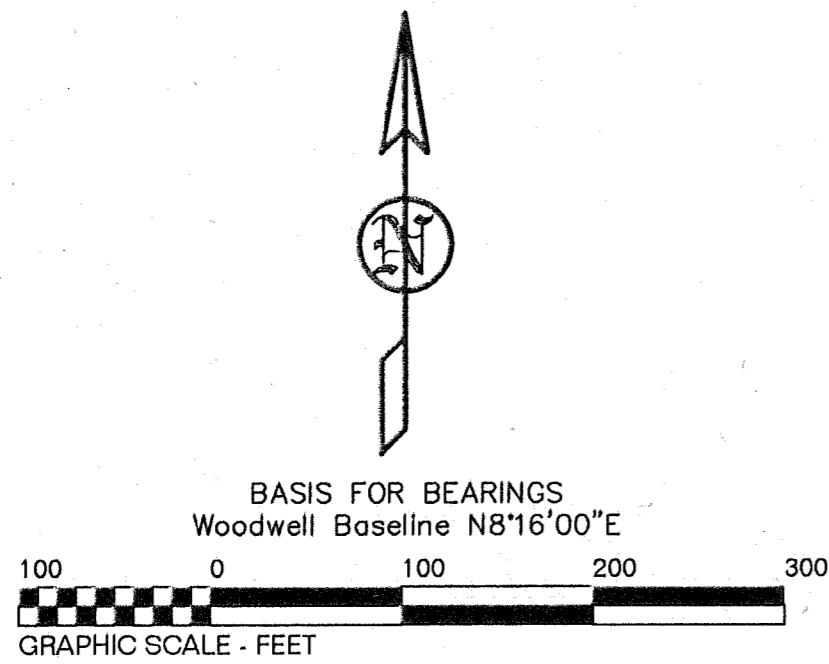


PARTITION PLAT No. P2014- 006

DECLARATION

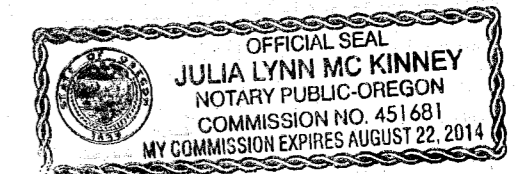

NARRATIVE

THE PURPOSE OF THIS PARTITION PLAT IS TO REPLAT PARCEL 2 OF PARTITION PLAT NO. P2004-019 IN THE SE1/4SE1/4 OF SECTION 32, T9S, R37E, WM, BAKER COUNTY, OREGON, INTO TWO PARCELS AT THE REQUEST OF DAVID McPHERSON.

THE WOODWELL BASE LINE AND ALL THE INFORMATION CONTAINED IN SURVEY NOS. 9-37-28 AND 9-37-180 ARE THE CONTROL FOR THIS SURVEY. AT THIS TIME THERE ARE NO OTHER PERMANENT CONTROL POINTS IN SUMPTER OTHER THAN THE WOODWELL BASE LINE FROM WHICH ALL RECENT SURVEYS HAVE BEEN TIED. A COMPLETE DESCRIPTION OF THE BASE LINE AND AN INTERPRETATION OF THE ORIGINAL PLAT DATA IS CONTAINED IN MAP OF SURVEY NO. 9-37-28 AND SURVEY NO. 9-37-180 SHOWS AN OVERALL SURVEY REVIEW OF THE AREA.

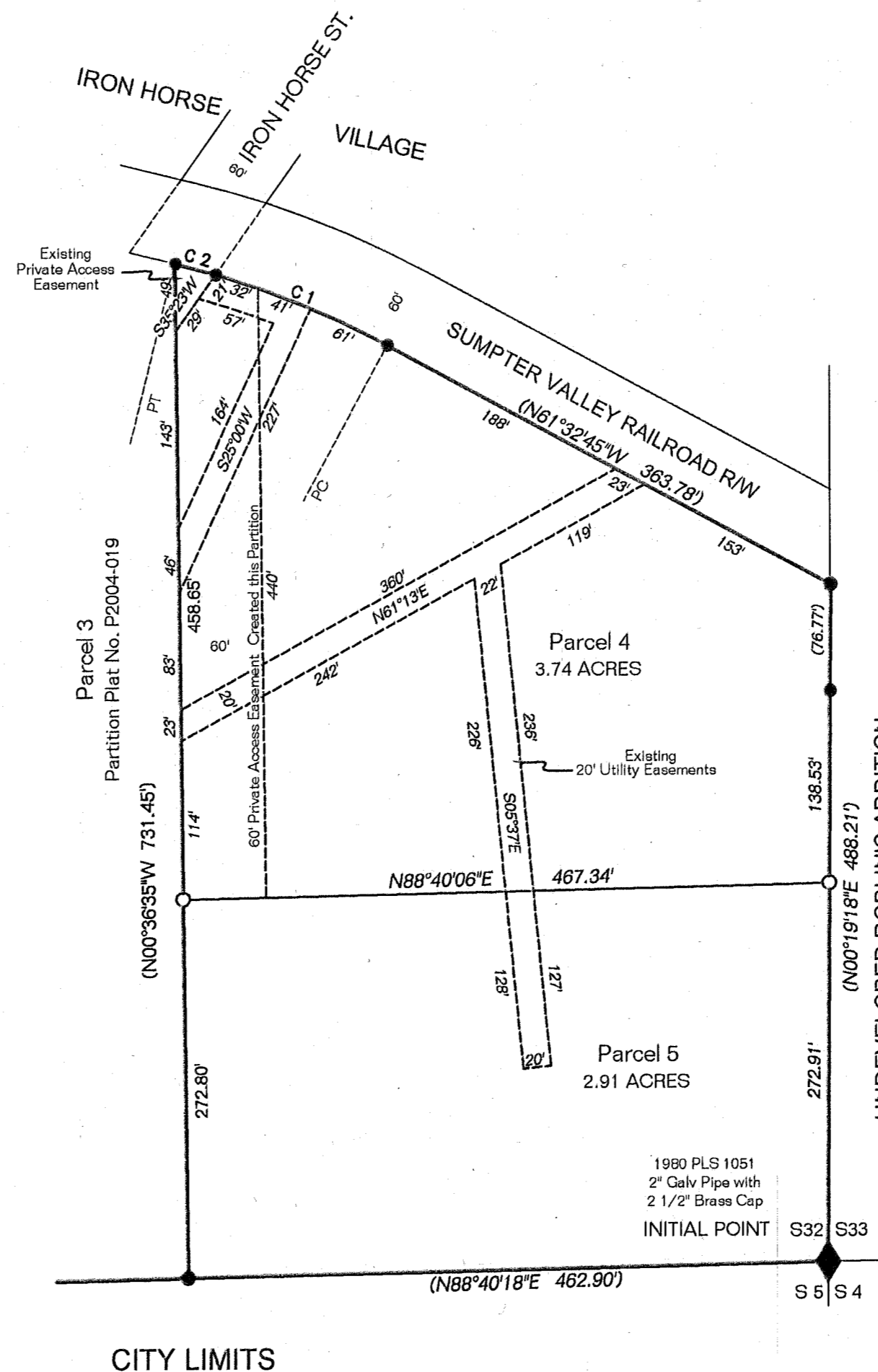
