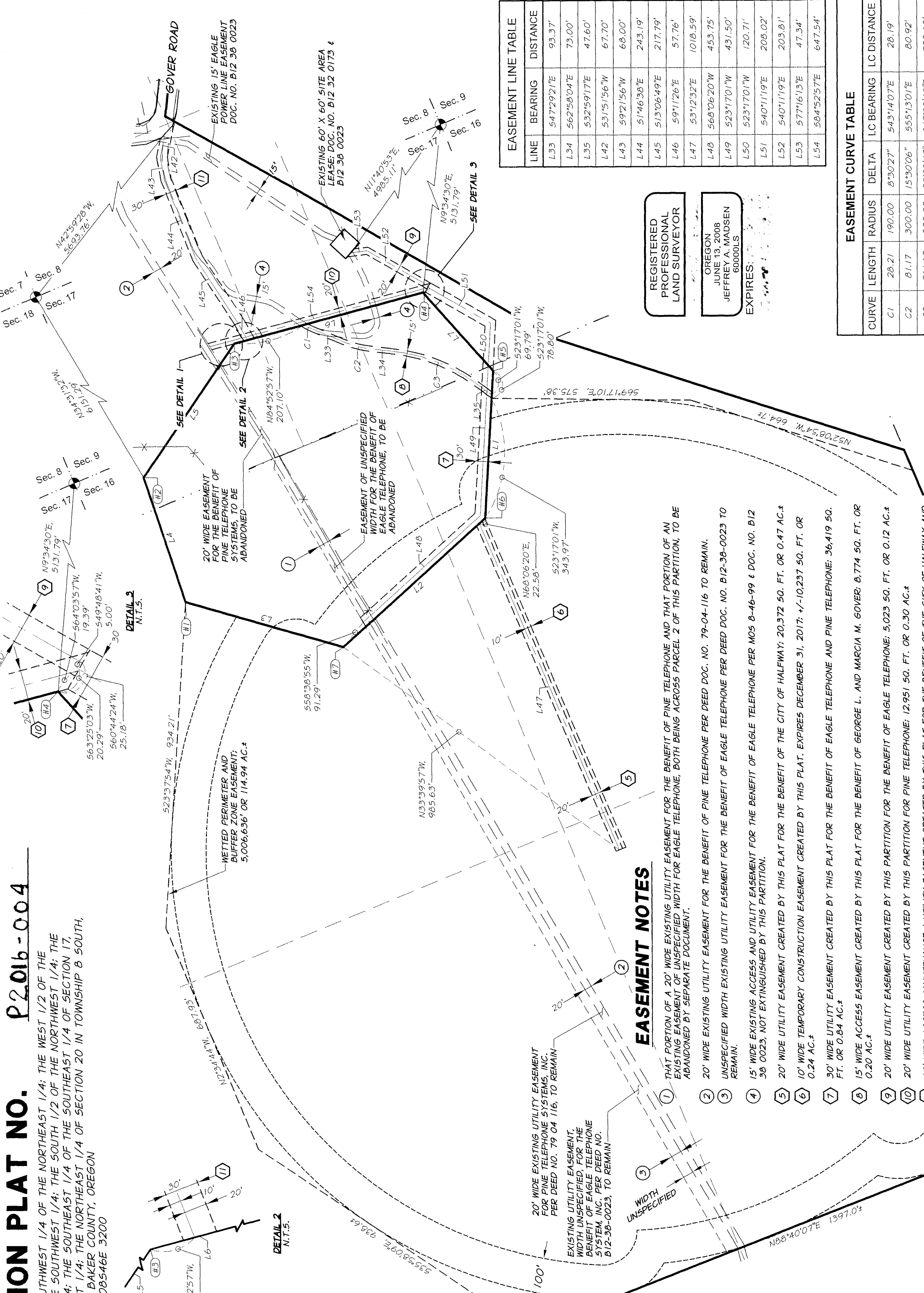

1. THAT PORTION OF A 20' WIDE EXISTING UTILITY EASEMENT FOR THE BENEFIT OF PINE TELEPHONE AND THAT PORTION OF AN EXISTING EASEMENT OF UNSPECIFIED WIDTH FOR EAGLE TELEPHONE, BOTH BEING ACROSS PARCEL 2 OF THIS PARTITION, TO BE ABANDONED BY SEPARATE DOCUMENT.
2. 20' WIDE EXISTING UTILITY EASEMENT FOR THE BENEFIT OF PINE TELEPHONE PER DEED DOC. NO. 79-04-116 TO REMAIN.
3. UNSPECIFIED WIDTH EXISTING UTILITY EASEMENT FOR THE BENEFIT OF EAGLE TELEPHONE PER DEED DOC. NO. B12-38-0023 TO REMAIN.
