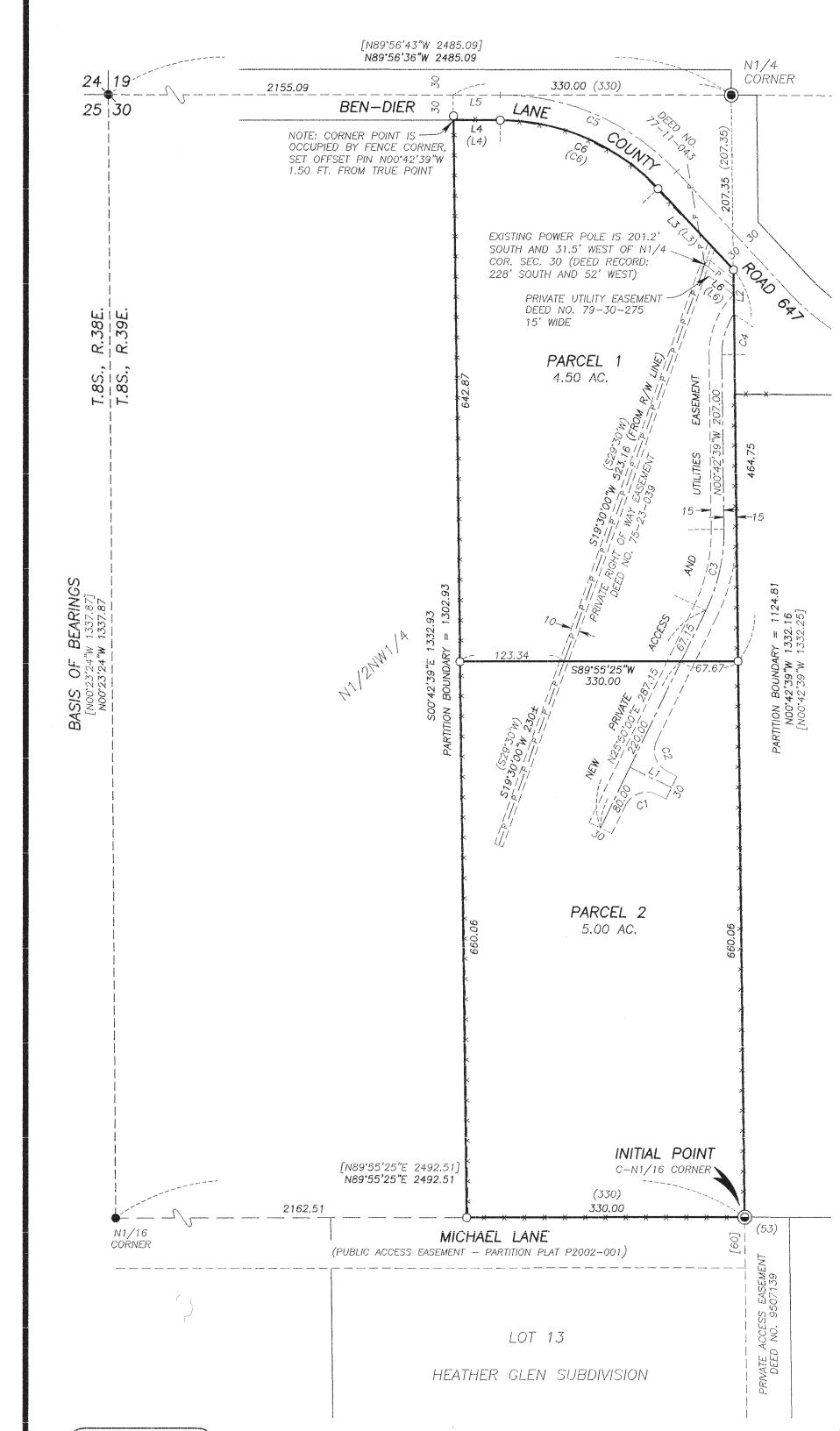

I, JASON L. HATFIELD, PROFESSIONAL LAND SURVEYOR, REGISTERED IN THE STATE OF OREGON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS, THE LAND REPRESENTED ON THIS PARTITION PLAT, SITUATED IN BAKER COUNTY, OREGON, DESCRIBED AS FOLLOWS:

TWP. 8 S., RANGE 39 E., W.M.:

SECTION 30: THE EAST 330 FEET OF THE NE1/4NW1/4 SECTION 30;

I DO HEREBY DESIGNATE THE SOUTHEAST CORNER OF PARCEL 2 OF THIS PARTITION AS THE INITIAL POINT, SAID POINT ALSO BEING THE CENTER-NORTH 1/16 CORNER OF SECTION 30, T.8S., R.39E., W.M.

- 1. RIGHTS OF THE PUBLIC IN AND TO ANY PORTION OF THE HEREIN DESCRIBED PREMISES LYING WITHIN THE BOUNDARIES OF STREETS, ROADS OR HIGHWAYS.
- 2. PRIVATE DITCH RIGHT OF WAY, INCLUDING THE TERMS AND PROVISIONS THEREOF, RECORDED DECEMBER 13, 1915, IN DEED BOOK 83, PAGE 564. SAID EASEMENT BEING 10 FEET IN WIDTH. NOT PLOTTED DUE TO INSUFFICIENT DATA IN THE DEED DESCRIPTION.
- 3. A PRIVATE EASEMENT, INCLUDING THE TERMS AND PROVISIONS THEREOF, GRANTED TO CALIFORNIA-PACIFIC ÚTILITIES COMPANY, A CORPORATION, RECORDED OCTÓBER 14, 1971 AS INSTRUMENT NO. 71 41 046. SAID EASEMENT BEING 10 FEET IN WIDTH. THE LOCATION OF THIS EASEMENT FALLS WITHIN THE DEEDED RIGHT OF WAY FOR BEN-DIER LANE, AND IS NOT PLOTTED.
- 4. A PRIVATE EASEMENT, INCLUDING THE TERMS AND PROVISIONS THEREOF, GRANTED TO CALIFORNIA—PACIFIC UTILITIES COMPANY, A CORPORATION, RECORDED JUNE 4, 1975 AS INSTRUMENT NO. 75 23 039. SAID EASEMENT BEING 10 FEET IN WIDTH, AS SHOWN
- 5. A PRIVATE EASEMENT, INCLUDING THE TERMS AND PROVISIONS THEREOF, GRANTED TO C P NATIONAL CORPORATION, A CORPORATION, RECORDED JULY 27, 1979 AS INSTRUMENT NO. 79 30 275. SAID EASEMENT BEING 15 FEET IN WIDTH, AS SHOWN HEREON.

6. EASEMENTS, RIGHTS OF WAY AND RESERVATIONS AS THE SAME MAY EXIST OR APPEAR

THIS PARTITION WAS PERFORMED AT THE REQUEST OF JENNIFER BLEDSOE AND MATTHEW HEDGPETH. THE PURPOSE OF THIS PARTITION IS TO DIVIDE THAT CERTAIN TRACT OF LAND DESCRIBED IN DEED NO. B17420129 INTO TWO PARCELS. THIS PARTITION WAS APPROVED BY THE BAKER COUNTY PLANNING DEPARTMENT BY ADMINISTRATIVE APPROVAL (MJP-18-001).

A SEARCH WAS MADE OF THE AVAILABLE RECORDS. FIELD MEASUREMENTS WERE MADE TO LOCATE APPURTENANT MONUMENTS FROM SURVEY NO. 8-39-79 AND THE PLAT OF HEATHER GLEN SUBDIVISION (SD2003--002). I ACCEPT ALL THE FOUND MONUMENTS SHOWN HEREON.

THE LOCATIONS OF PRIVATE UTILITY EASEMENTS AFFECTING THE PROPERTY WERE DETERMINED BY THE EXISTING POWER POLES AND OVERHEAD LINES.

NEW MONUMENTS WERE SET AT LOCATIONS ACCORDING TO THE EVIDENCE FOUND AND AS APPROVED BY MS. BLEDSOE AND MR. HEDGPETH. THE NORTHWEST CORNER OF PARCEL 1 IS OCCUPIED BY A ROCK JACK FENCE CORNER, SO I SET AN OFFSET PIN N.00°42'39"W., 1.50 FEET FROM THE TRUE POINT.

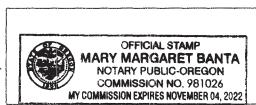

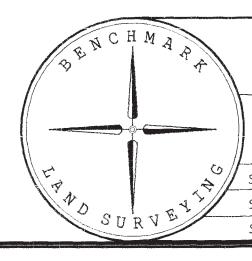
