#### SURVEYOR'S CERTIFICATE

I, Thomas J. Hanley, certify that I have correctly surveyed and platted two parcels of land on this minor partition plat in accordance with O.R.S. Chapter 92. The boundary of the partition is as follows;

Land located in the Northeast quarter of the Southwest quarter of Section 33, Township 7 South, Range 39 East, Willamette Meridian, in Block 2 of Long's Addition in the City of Haines, Baker County, Oregon, more particularly described as follows:

Beginning at the intersection of the South right of way of Third Street and the East right of way of Long Street being the Northwest corner of said Lot 7, the Point of Beginning; thence N. 62° 44' 14" E., 100.02 feet to the Northeast corner of this said Lot 7; thence S. 27° 15′ 19″ E., 150.02 feet to the Southeast corner of said Lot 9; thence S. 62° 43′ 52″ W., 100.02 feet to the Southwest of said lot 9; thence N. 27° 15′ 13″ W., 150.02 feet to the Point of Beginning.


