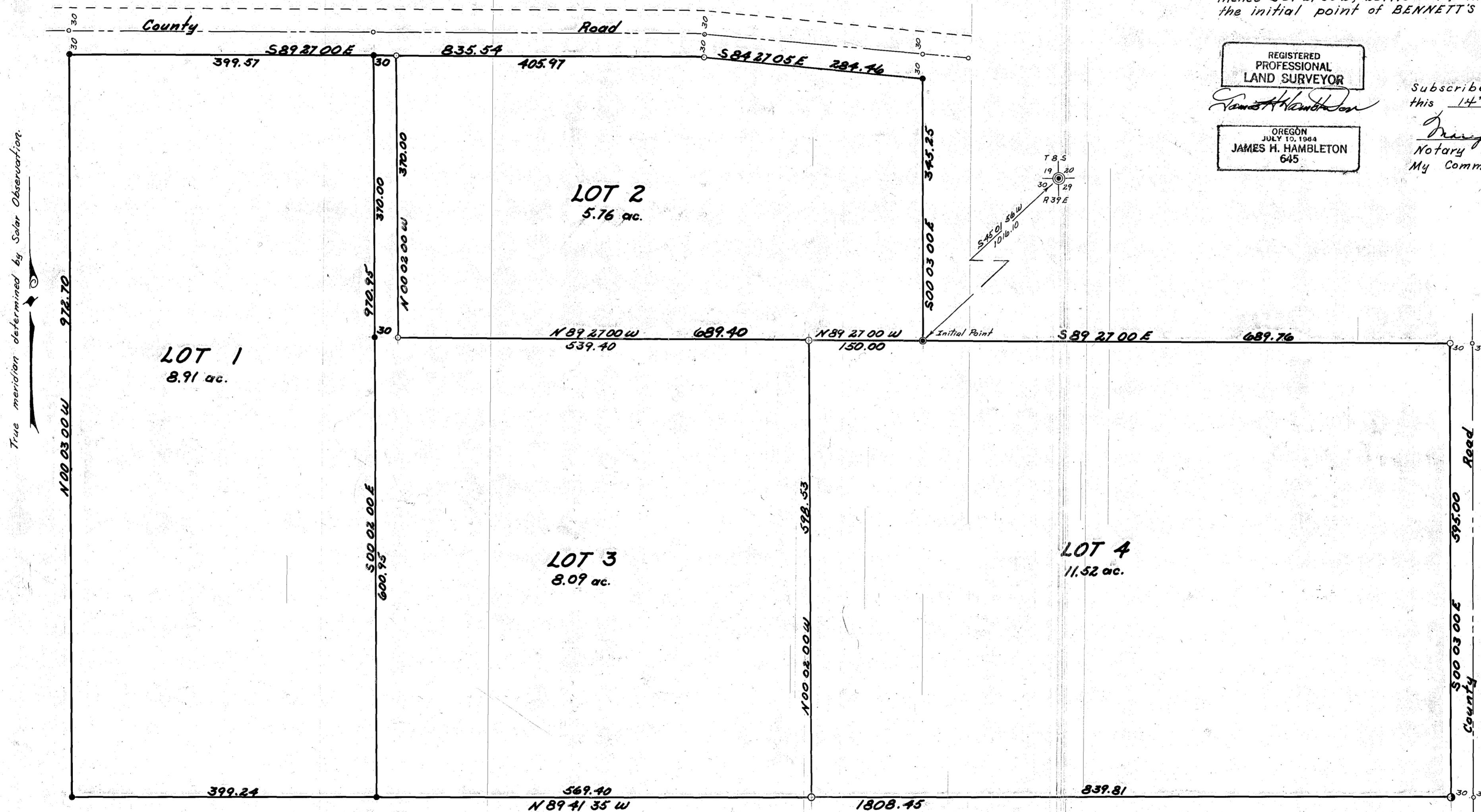


BENNETT'S BEND SUBDIVISION

Hambleton, being first duly sworn, say that I have correctly surveyed and platted BENNETT'S BEND SUBDIVISION as represented on the annexed map, and at the initial point of said survey a 2-inch galvanized iron pipe 36-inches long was set below the surface of the ground, said initial point being S 45° 01' 56" W, 1016.10 feet from the North-east corner of section 30, T8S, R39E, Willamette Meridian; thence S 89° 27' 00" E, 689.76 feet; thence S 00° 03' 00" E, 595.00 feet; thence N 89° 21' 35" W, 1808.45 feet; thence N 00° 03' 00" W, 972.70 feet; thence S 89° 27' 00" E, 835.54 feet; thence S 84° 27' 05" E, 284.46 feet; thence S 00° 03' 00" E, 345.25 feet to the initial point of BENNETT'S BEND SUBDIVISION.



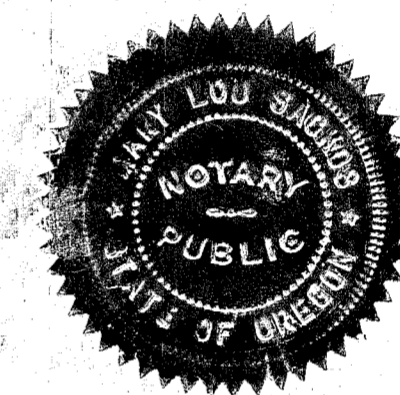
