NARRATIVE

THE PURPOSE OF THIS PLAT IS TO SUBDIVIDE LOT 26 OF REPLAT NO. SD2008-003.

SEARCH IN THE FIELD LOCATED AND HELD MONUMENTATION OF BIRCH ESTATES SUBDIVISION. THE NORTHWEST CORNER OF THE ELKHORN BAPTIST CHURCH PARCEL WAS FOUND TO BE 0.35 FEET FROM RECORD POSITION AND THE SOUTHWEST CORNER OF THE ELKHORN BAPTIST CHURCH PARCEL WAS FOUND TO BE 0.31 FEET FROM RECORD POSITION. THESE MONUMENTS WERE REJECTED AND NEW PINS WERE SET IN RECORD POSITIONS, WITH BEARINGS AND DISTANCES AS SHOWN. OTHER EXISTING MONUMENTATION AS SHOWN IN THIS PLAT WAS FOUND AND HELD. SURVEY WAS PERFORMED USING A PENTAX III-10 TOTAL STATION.
