Beginning at the quarter corner common to Sections 8 and 17, T 9S, R 40E, W.M., in the City of Baker, Baker County, Oregon; thence northerly towards the center of said section 8, a distance of 910.0 feet; thence easterly a distance of 109.0 feet; thence southerly a distance of 10.0 feet; thence easterly a distance of 318.0 feet; thence northerly a distance of 10.0 feet; thence easterly a distance of 112.0 feet to a point on the prolongation of the center line of Seventh Street in the said City of Baker; thence southerly along the prolongation of said Seventh Street to a point on the section line common to the said sections 8 and 17, a distance of 907.0 feet; thence westerly along said section line, a distance of 535.16 feet, to point of beginning.
