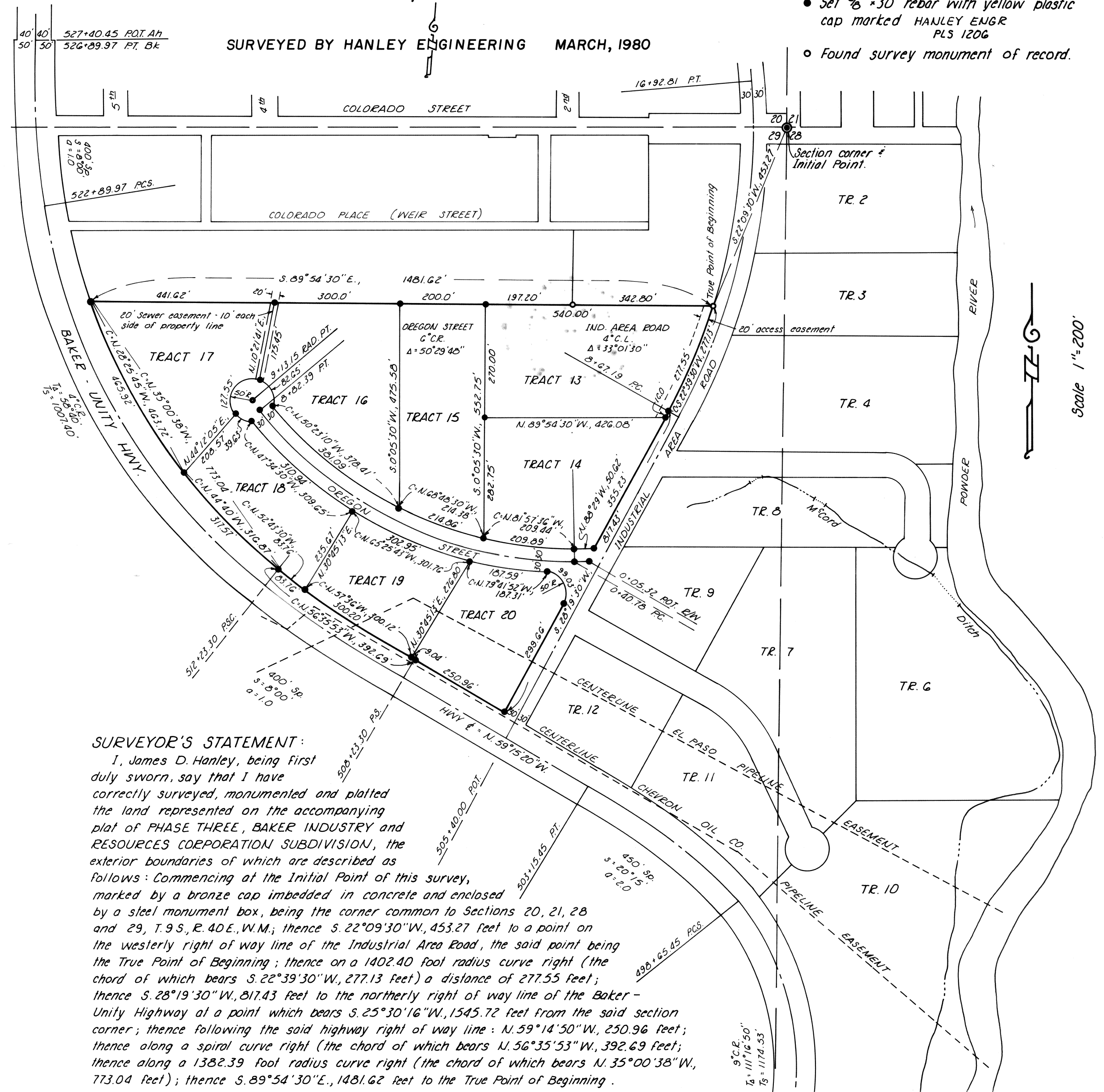

SURVEYOR'S STATEMENT:

I, James D. Hanley, being First duly sworn, say that I have correctly surveyed, monumented and platted the land represented on the accompanying plat of PHASE THREE, BAKER INDUSTRY AND RESOURCES CORPORATION SUBDIVISION, the exterior boundaries of which are described as follows: Commencing at the Initial Point of this survey, marked by a bronze cap imbedded in concrete and enclosed by a steel monument box, being the corner common to Sections 20, 21, 28 and 29, T.9 S., R.40 E., W.1 M.; thence S. 22°09'30" W., 453.27 feet to a point on the westerly right of way line of the Industrial Area Road, the said point being the True Point of Beginning; thence on a 1402.40 foot radius curve right (the chord of which bears S. 22°39'30" W., 277.13 feet) a distance of 277.55 feet; thence S. 28°19'30" W., 817.43 feet to the northerly right of way line of the Baker - Unity Highway at a point which bears S. 25°30'16" W., 1545.72 feet from the said section corner; thence following the said highway right of way line: N. 59°14'50" W., 250.96 feet; thence along a spiral curve right (the chord of which bears N. 56°35'53" W., 392.69 feet); thence along a 1382.39 foot radius curve right (the chord of which bears N. 35°00'38" W., 773.04 feet); thence S. 89°54'30" E., 1481.62 feet to the True Point of Beginning.
