CLARK'S ADDITION

FORMERLY PART OF BLOCK 13 OF ATWOOD'S SECOND ADDITION BY H. L. MELTON, CITY ENGR.

I, Henry L. Melton, being duly sworn do testify and say that I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are described as follows: Beginning at an Iron-Pin Monument at the intersection of the West line of Clark Street and the South line of Campbell Street, said initial point being S.59°39'W. 59.37 feet from the iron monument at the intersection of the center lines of Campbell and Clark Streets and is the Northeast Corner of the Tract hereafter Known as Clark's Addition to the City of Baker, Oregon. Thence S.29°32'W. along the West line of Clark Street 460.32 feet to an iron monument which is the S.E. Corner of the above mentioned tract, and is the intersection of the North line of Madison and West line of Clark Streets, thence S.89°23'30"W. three hundred and three one hundredths (300.03) feet along the North line of Madison Street to an intersection of the East line of East Street, which is the Southwest Corner of the above mentioned tract and is the S.W. Corner of what was formerly known as Lot 16 of Block 13 of Atwood's Second Addition, thence N.0°31'30"W. along the East line of East Street, one hundred and thirty-nine one hundredths (100.39) feet to an iron monument at the N.W. corner of Lot 15 of this addition and formerly Lot 15 of Block 13 of Atwood's Second Addition, thence N.89°27'30"E. along the line between Lot 14, Block 13, Atwood's Second Addition and Lot 15 Clark's Addition one hundred and fifty (150.0) feet to the N.E. corner of Lot 17, Block 1, Clark's Addition and formerly Lot 17, Block 13 Atwood's Second Addition, thence N. 0°31'30"W. three hundred and forty-three one hundredths (300.43) feet to an iron monument at the intersection of the South line of Campbell Street and that is the N.W. corner of the above mentioned tract and the N.E. corner of Lot 8, Block 13, Atwood's Second Addition, thence N.89°46 E. three hundred eighty and SIX tenths (380.6) feet to the point of beginning. Said tract being a part of the N.E. 4 of the S.W. 4 of Section Sixteen (16), Township Nine (9) South, Range Forty (40) East of the Willamette Meridian of Oregon and said Tract being all of Lots 1 to 7 and 15 to 20 and other tracts in Block 13 of Atwood's Second Addition to the City of Baker, Oregon, and that I marked on the ground with proper monuments, the subdivision as represented, by monumenting and staking the boundaries as indicated and placing iron plins as above stated.
