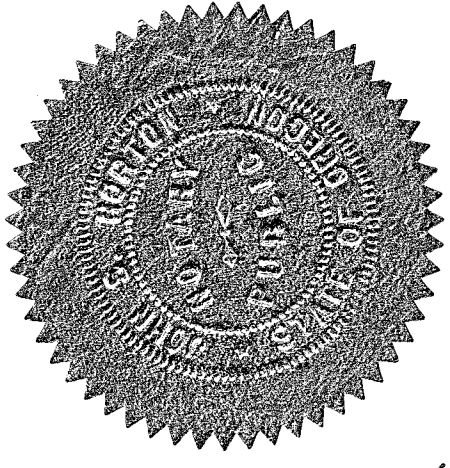

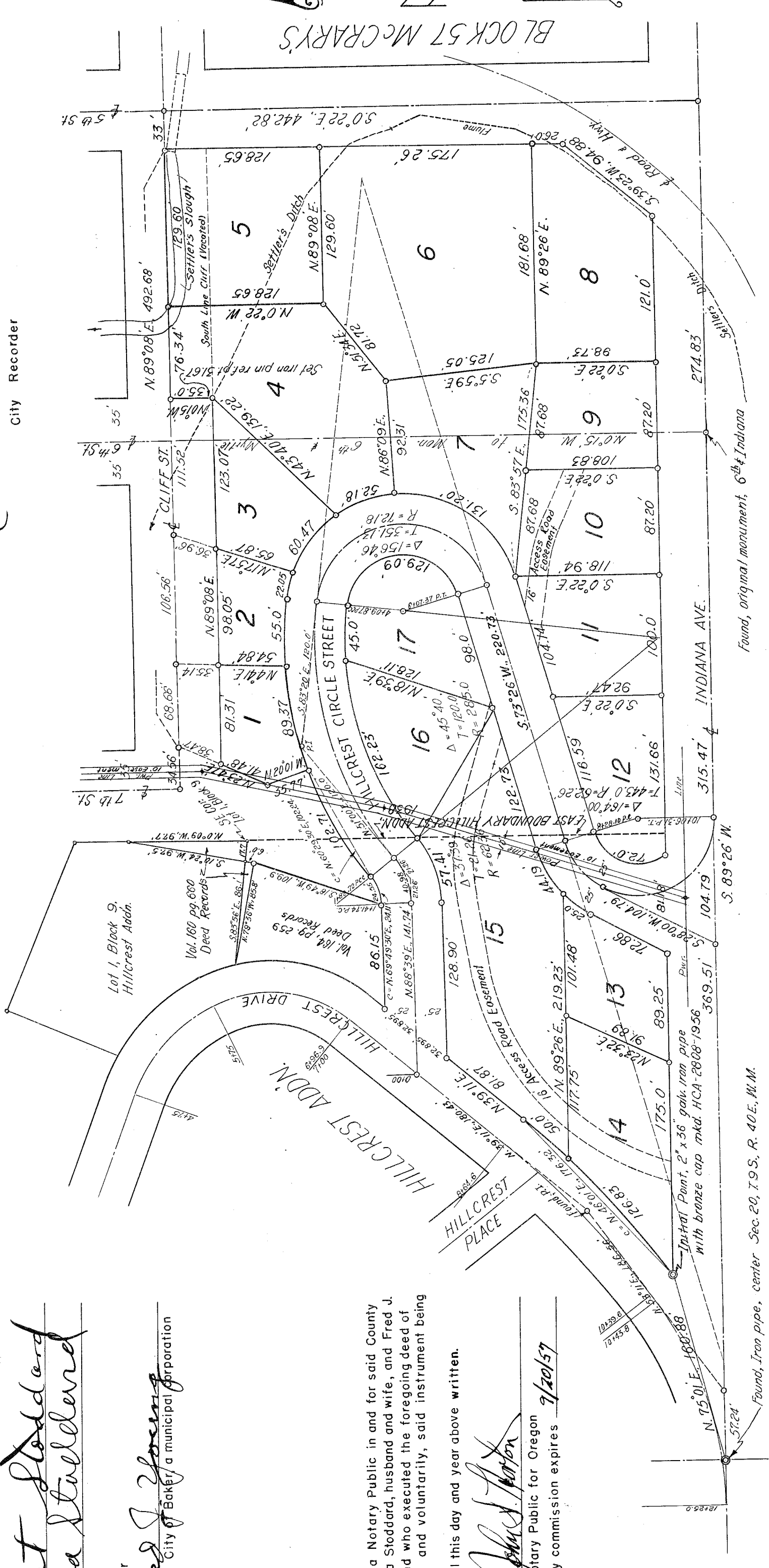

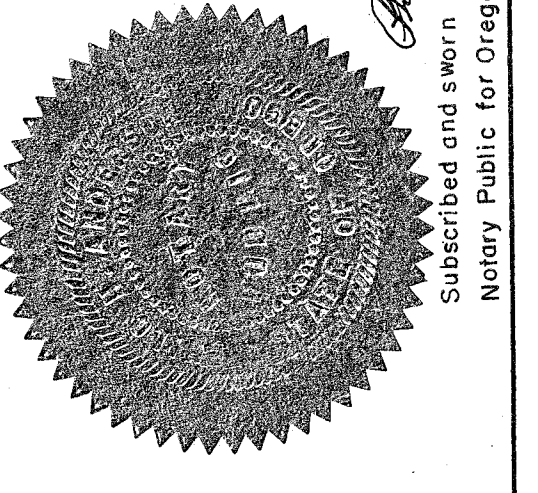
CERTIFICATE OF PLANNING COMMISSION

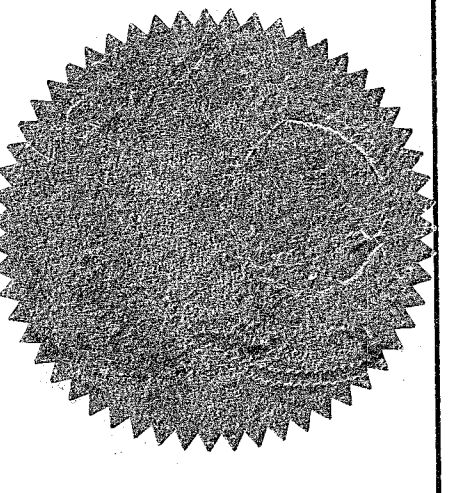

I, James D. Hanley, being first duly sworn, say that I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are described as follows: - Beginning at the intersection of the Easterly line of Hillcrest Drive with the Northernly line of Indiana Avenue, said point being N. 75° 01' E., 160.88 ft. distant from the center of Section 20, T. 9 S., R. 40 E., W. 1/2; thence on a 742.20 ft. radius curve left (the chord of which bears N. 46° 01' E., 176.52 feet) a distance of 176.83 feet; thence N. 88° 39' E., 86.15 ft.; thence on a 37.36 ft. radius curve left (the long chord of which bears N. 60° 29' 30" E., 102.24 feet) a distance of N. 69° 49' 30" E., 24.11 feet) a distance of 24.55 feet; thence on a 310.0 ft. radius curve right (the chord of which bears N. 60° 29' 30" E., 102.24 feet) a distance of 102.71 feet; thence N. 20° 01' W., 35.77 ft.; thence N. 23° 47' E., 41.48 ft.; thence N. 89° 08' E., 300.49 ft. along the South line of Cliff St. to the Easterly line of 6th St.; thence N. 0° 15' W., 35.0 ft. to the center line of Cliff St.; thence N. 89° 08' E., 205.94 ft. along the center line of Cliff St.; thence N. 89° 26' W., 872.53 ft. along the North line of Indiana to the point of beginning. Hillcrest Circle Addition is located in the SW 1/4 NE 1/4 of said Sec. 20, and I have marked on the ground, the subdivision as represented, in accordance with the law.
