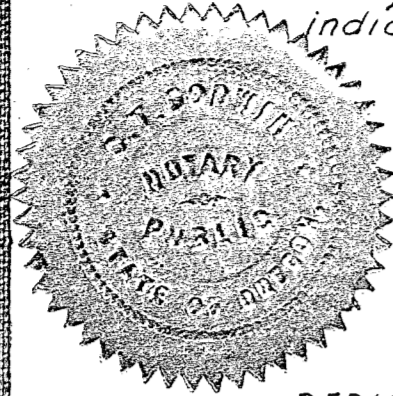


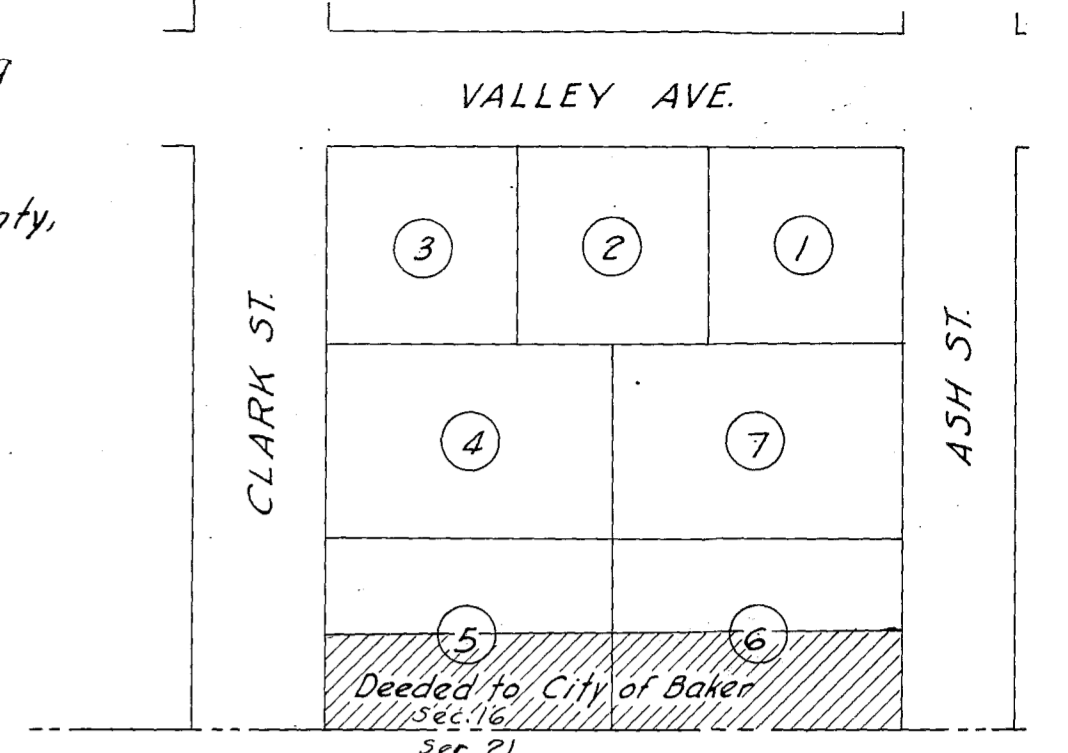

DEDICATION CERTIFICATE:

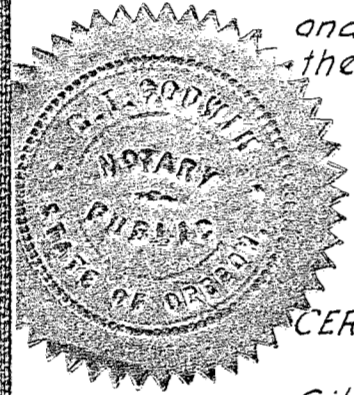

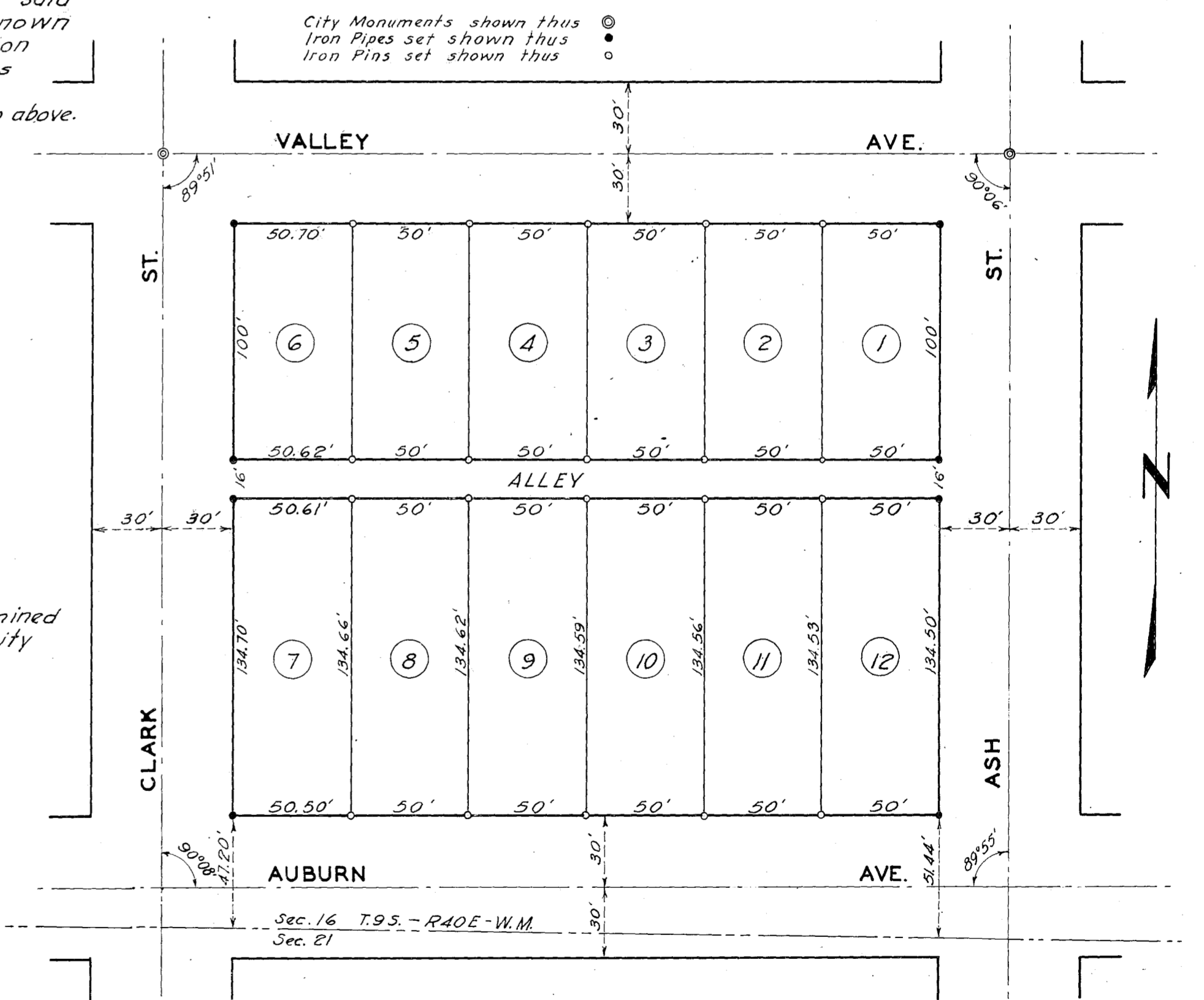
