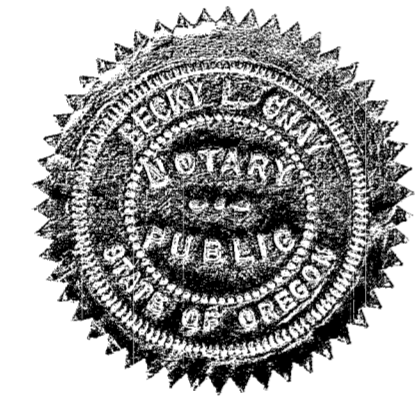

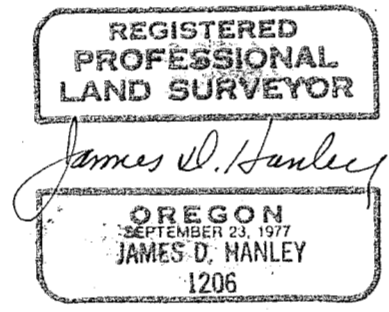
SURVEYOR'S STATEMENT
 I, James D. Hanley, being first duly sworn, say that I have correctly surveyed and platted the land represented on the accompanying plat of **MATHESON SUBDIVISION**, the exterior boundaries of which are described as follows:

Beginning at the Initial Point of this survey, marked by a galvanized iron pipe 2 inches diameter, thirty-six inches long, set six inches below the ground surface, at a point which is 115 feet South and 295.66 feet West of the Northeast corner of Lot 1, Usher's South Addition (Deed 77-16-082), the said I.P. further described as being N.36°59'30"W, 550.90 feet from the SE cor. of the NW 1/4 SE 1/4 of Sec. 23, T. 9 S., R. 45 E., W. M.; thence S.0°08'15"W, 439.68 feet (South 443 ft. M/L); thence N.89°56'32"W, 194.5 feet (West, 194.5 ft.); thence N.0°08'15"E, 439.53 feet (North, 443 ft. M/L) to the South line of the alley in said addition; thence S.89°59'15"E, 194.5 feet (East, 194.5 ft.) to the point of beginning.

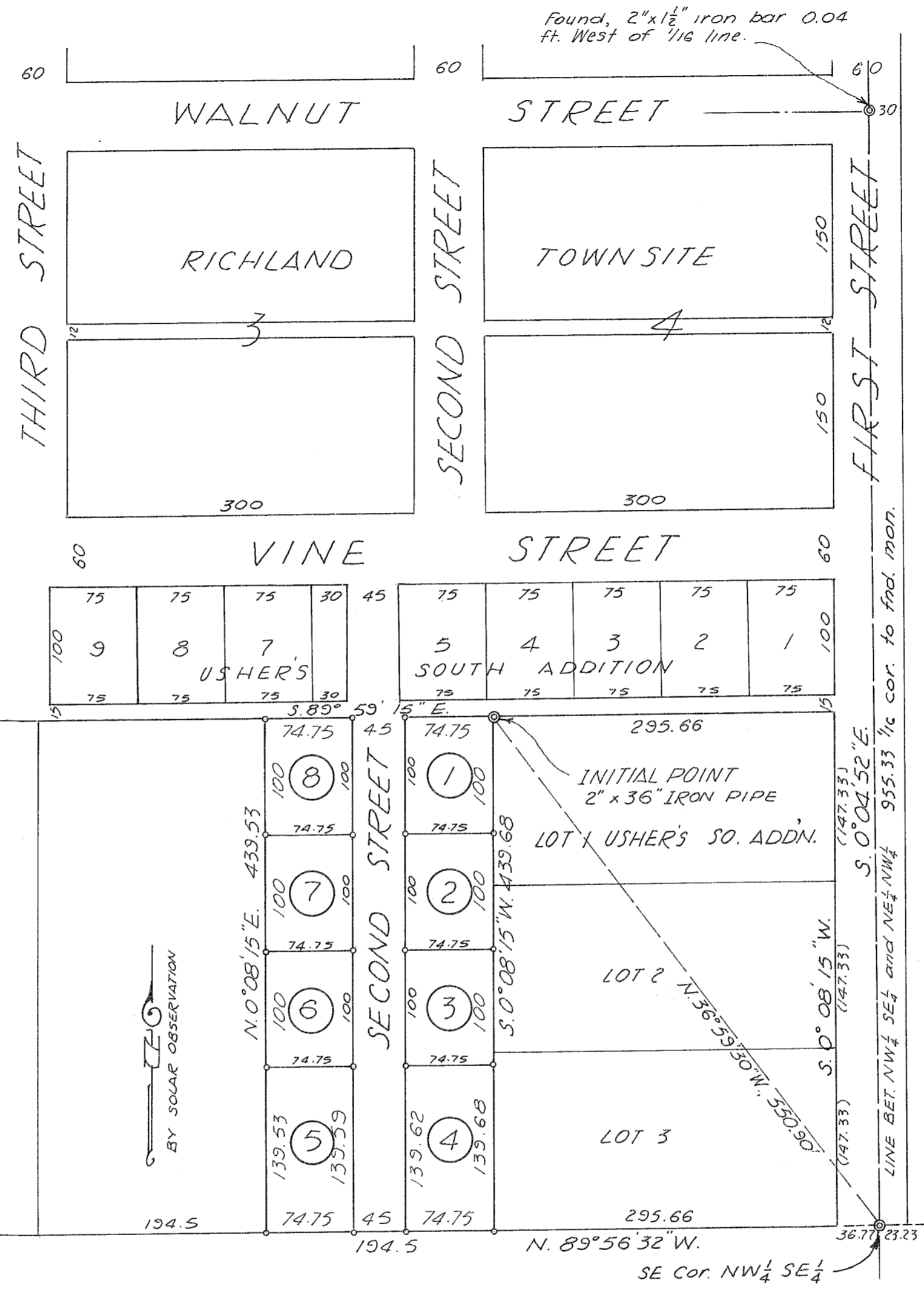
