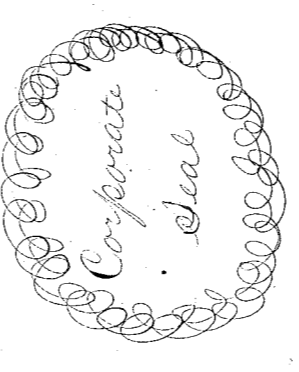


Know all whom it may concern that whereas the Nelson Real Estate Association a corporation

 its President and Secretary and its corporate seal to be hereunto set.

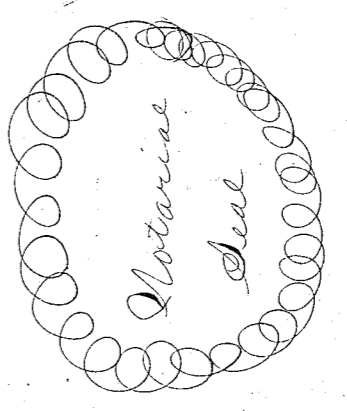

 do hereby dedicate public use all the streets shown on said annexed map.

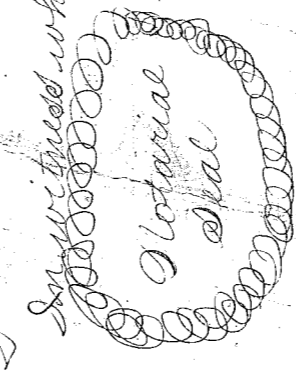

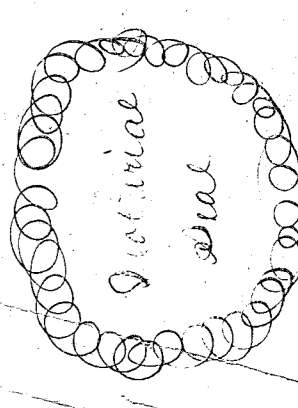
