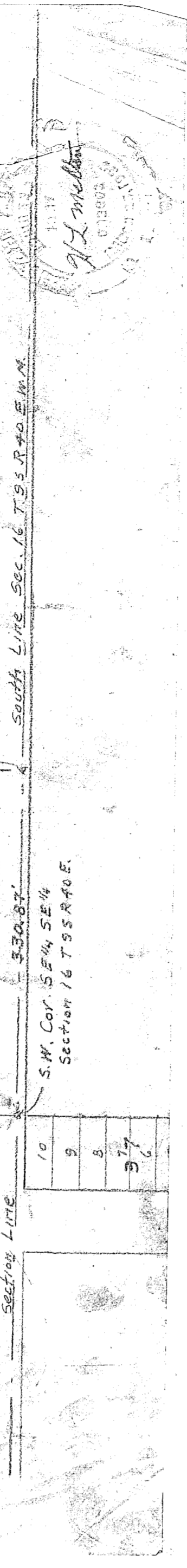

The hereby dedicate to public use all that portion of the land depicted which is represented upon said map as streets and except all ways to the full extent and dimensions as represented upon said map save and except all ways for the abn. dedication the right of way over in and upon all the streets and avenues for Street Railways and Street Railways purposes which is hereby dedicated and granted herein in clear and unobscured form any one to the Baker City Street Railway and Motor Company a private corporation organized under the general laws of the State of Oregon
