SURVEYOR'S STATEMENT

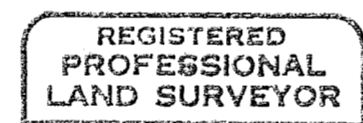
I, James D. Hanley, being first duly sworn, say that I have correctly surveyed and plotted the land represented by the accompanying plat of SPARTA RECREATION LANDS, the exterior boundary of which encompasses Mineral Survey No. 867 known as the Pathfinder Group, excepting the New York lode therefrom, and further described as follows: Beginning at the Initial Point of this survey marked by a galvanized iron pipe, two inches in diameter, thirty-six inches long, and set six inches below the ground surface, at a point which is S. 78°16'35"E., 1772.04 feet from the corner common to Sections 24 and 25, T. 7S., R. 43E., W.M. and to Sections 19 and 30, T. 7S., R. 44E., W.M., said point also being Cor. No. 3 of the Mohican lode of the said Mineral Survey No. 867; thence S. 31°33'10"W., 599.69 feet to Cor. No. 4 of the Mohican lode; thence N. 59°08'15"W., 1495.14 feet to Cor. No. 1 of the Mohican lode, identical with Cor. No. 1 of the Eclipse lode; thence N. 57°53'35"W., 1503.59 feet to Cor. No. 2 of the Eclipse lode, identical with Cor. No. 1 of the Sovereign lode; thence N. 58°36'55"W., 1505.75 feet to Cor. No. 2 of the Eclipse lode; thence N. 31°40'10"E., 1199.08 feet to Cor. No. 4 of the Coin lode; thence S. 58°50'25"E., 1499.84 feet to Cor. No. 1 of the Coin lode, identical with Cor. No. 4 of the Goodyear lode and Cor. No. 3 of the London lode; thence N. 31°02'25"E., 602.96 feet to Cor. No. 4 of the London lode, identical with Cor. No. 3 of the Foster lode and Cor. No. 2 of the New York lode; thence N. 32°11'15"E., 592.91 feet to Cor. No. 1 of the New York lode, identical with Cor. No. 4 of the Foster lode; thence S. 58°41'55"E., 1491.34 feet to Cor. No. 1 of the Foster lode; thence S. 31°38'50"W., 600.57 feet to Cor. No. 2 of the Foster lode, identical with Cor. No. 1 of the London lode; thence S. 30°00'50"W., 605.89 feet to Cor. No. 2 of the London lode, identical with Cor. No. 1 of the Goodyear lode; thence S. 31°32'05"W., 600.27 feet to Cor. No. 2 of the Goodyear lode, identical with Cor. No. 4 of the Sovereign lode and Cor. No. 3 of the Eclipse lode; thence S. 58°30'50"E., 1500.52 feet to Cor. No. 4 of the Eclipse lode, identical with Cor. No. 2 of the Mohican lode; thence S. 58°30'30"E., 1500.40 feet to Cor. No. 3 of the Mohican lode and the point of beginning.
