


MAP OF ROBLIN'S ADDITION

Surveyor's Certificate.

I hereby certify to be correct the Survey and Plat herewith of Roblin's Addition to the Town of Sumpter, Baker County, Oregon, Being a subdivision of the SW 1/4 of the SW 1/4 of Section 33, T 9 S., R. 31 E. W.M. More particularly described as follows:

Beginning at the initial Point (P) identical with the SW corner of Section 33, thence along Section Line between Secs. 33 and 39, N 01° E. 128.5 feet to a stake, thence N 87° 29' E. 320.0 feet to a stake, thence S. 01° 38' W. 128.5 feet to a stake, thence along South Line of Sec. 33, S. 87° 32' W. 1320.3 feet, to the place of beginning, containing 38.97 Acres.

The dimensions of the Lots, Blocks, Streets and Alleys are as shown on this Plat.

Dedication.

Know ALL MEN BY THESE PRESENTS, That I, Charles E. Roblin do hereby declare, this Map and do hereby dedicate to the use of the Public forever all the Avenues, Streets, Alleys, Highways and Parks thereon, excepting all Minerals therein contained and all timber thereon and reserving to myself the right to lay down Railways thereon and propel cars thereon by steam or other motive power, to lay down pipes and wires thereon to erect poles and extend wires thereon for the purposes of conducting electricity for telephoning, telegraphing and electric lights.
