I hereby certify to be correct, the Survey and Plat herewith of Roblin's Addition to the Town of Sumpter, Baker County, Oregon. Being a subdivision of the S.W. 1/4 of the S.W. 1/4 of Section 33, T.9 S. - R.37 E. - W.1 M. More particularly described as follows, to-wit: Beginning at the Initial Point (I.P.) identical with the S.W. corner of Section 33, thence along Section Line to a stake, Sec. 33 and 39, N. 0° 18' E. 1285 feet to a stake, thence N. 89° 52' E. 132.03 feet to a stake, thence along Section Line of Sec. 33, S. 89° 32' W. 132.03 feet to the place of beginning, containing 28.97 Acres. Roblin do hereby declare this Map and do hereby dedicate to the use of the Public forever all the Avenues, Streets, Alleys, Highways and Parks thereon, reserving all Minerals therein contained and all timber thereon and reserving the exclusive right to lay down Railways therein and propel cars thereon by steam or other motive power, to lay down pipes and wires thereon to erect poles and extend wires thereon for the purposes of conducting electricity for telephoning, telegraphing and electric lights.
