Description of corner evidence found:

Found 27 x 8 x 7 inch slate stone with 3 notches on south and 5 notches on east edges. A pine stump scribed "BT" bears Sl5°W, 37 ft. Stump N42°W, 35.0 ft., no scribing. A stump bears N48°E 45.3 ft., no scribing. Note. Near an East-West fence and compass may be pulled. SW stump has 54-3.

Description of monument and accessories I established to perpetuate the original location of this corner:

At center of above described stone set 2 1/2" x 30" galvanized pipe and brass cap marked: Set pipe 22" in the ground and mound of stone around to cap. Placed marked stone at base of pipe.
