

NARRATIVE

This survey was done at the request of Bill Loennig, owner of the land surrounding the 5 acre tract shown here. Mr. Loenning wanted the parcel surveyed prior to installation of a buried mainline. I find that the legal description is based on courses of Survey Number 07-38-21. I recover monuments of said survey and find them harmonious with record. For the West line of this parcel, I hold the found pins for line, and extend the line to called deed distance. From this point, I hold a line parallel with the pins that are nominally due East, set by said survey, and extend this line the deed distance of 450 feet. The East line I run parallel with the West, and the South line I run parallel with the North. The South line, placed as such, is very harmonious with the right-of-way fences.

There is a patent ambiguity in the legal description of the 5 acre parcel in the sense that it is written as being a portion of an aliquot part laying North and West of a described line, and proceeds to describe a closed polygon. I find that the intent of conveyances is likely to convey the 5 acres parcel described by metes and bounds, and the portion that states "lying North and West of the following line" is likely erroneous.

I find no other unusual conditions with this survey.

Geodetic North taken at the Southwest corner of Section 23, Township 7 South, Range 38 East of the Willamette Meridian, as determined by GPS observation
