I, Thomas J. Hanley, certify that I have correctly surveyed and platted two parcels of land on this partition plat in accordance with O.R.S. Chapter 92. The boundary of the partition is as follows:
 Land located in the Northeast quarter of the Southwest quarter of Section 33, Township 7 South, Range 39 East, Willamette Meridian, in the City of Haines, Baker County, Oregon, more particularly described as follows:
 Beginning at the intersection of the Southerly right of way of Fifth Street and the Westerly right of way of Ruby Street; thence S. 27°17'13" E., along said Westerly right of way of Ruby Street, 175.46 feet to intersect the South line of said Northeast quarter of the Southwest quarter; thence S. 89° 56'04" W., along said South line, 299.57 feet; thence N. 09°24'38" W., 40.37 feet to said Southerly right of way of Fifth Street; thence N. 62°42'47"E., along said Southerly right of way, 254.00 feet to the Point of Beginning.

Partition contains 28,250 square feet of land.

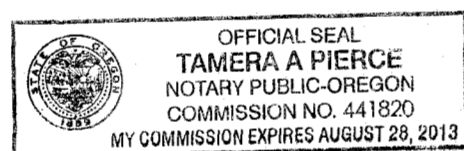

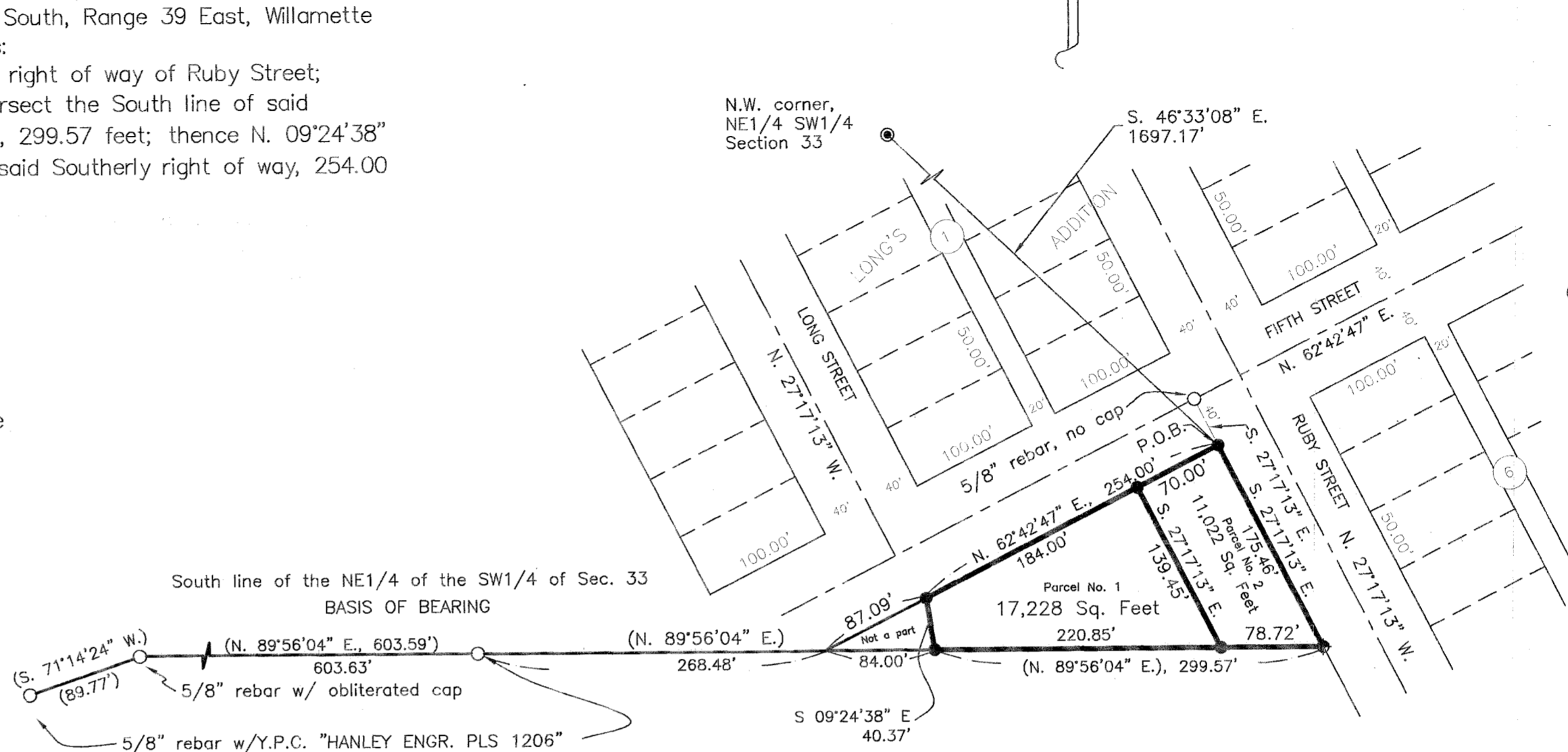

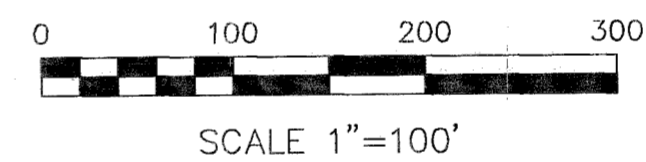

 SOUTH LINE OF THE NEX. SW1/4 OF SECTION 33 BEARS N. 89°56'04\"/>

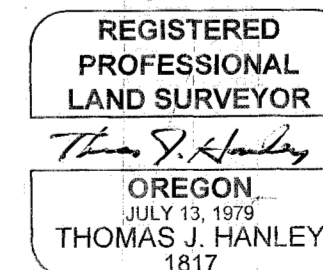
