BASIS OF BEARING

Solar observation taken at a point 3550 feet South and 3360 feet West of the Northeast corner of Section 22, Township 6 South, Range 39 East of the Willamette Meridian, as per Partition Plat No. P2011—010

- Found unrecorded 1" rebar, 6" below grade. Due to harmony in position, accepted as perpetuation of Section Corner

NARRATIVE

This partition was done at the request of Rebecca Knapp, legal representative for Trevor Collins, owner of the land within. Mr. Collins wanted to adjust the lines as shown. I recover monuments as shown. At the SE corner of Section 32, the corner falls in the centerline of Coffey Rd. Excavation to a depth of 14 inches reveals no trace of the 1/2" rebar set by Survey Number 07-40-003. By the sound of the metal detector, I estimate any ferrous material would be an additional 2 feet further down and would require undue destruction of the road surface to recover. I recover the Southwest township corner and a 1" rebar at the Southeast corner of Section 33, which due to the harmony between record measurement, I accept as being a perpetuation of this corner. I use a scale/rotation (Grant boundary adjustment method) to place the position of the Southeast corner of Section 32. This places the position directly above the sound of the unrecoverable monument described above. I reset a brass cap flush with the road surface. Adjusted lines are placed at the direction of the landowner. The original petition for Coffey Road indicates the road was created along section lines. I find the North right of way line to be South 3-4 feet from the right of way fence. I find no other unusual conditions with this survey.
