NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO DEFINE THOSE CERTAIN TRACTS OF LAND DESCRIBED IN 806 48 0063, BAKER COUNTY RECORDS, BEING SITUATED IN THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 20, TOWNSHIP 7 SOUTH, RANGE 43 EAST, WILLAMETTE MERIDIAN, BAKER COUNTY, OREGON, AND TO PARTITION SAID TRACTS INTO THREE PARCELS, AT THE REQUEST OF CHARY MIRES, LINDA TRIPLETT AND JAMES

MONUMENTS WERE FOUND AND HELD PER BAKER COUNTY SURVEY 7-43-204.

MONUMENTS WERE SET TO MARK THE BOUNDARIES OF THE PARTITIONED PARCELS, AS


