History of original corner establishment:

Corner was originally established under G. L. O. contract number 503, by W. B. Barr, on June 2, 1884. Surveyor General's notes state: "Set granite rock 10 X 10 X 8 ins. 7 inches in fround for 1/4 sec. cor. marked 1/4 on the N. side. From which a fir 14 ins. diam. bears S83°E, 114 lks. dist. marked 1/4S BT. A fir 7 ins. diam. bears N10°E, 54 1ks. dist. marked 1/4S BT."

In 1974 the BLM remonumented this corner. Official notes state: "At corner point, Set an iron post, 28 ins. long, 2 1/2 ins. diam., 18 ins. in the ground to bedrock, and in a mound of stone, 3 ft. base, to top, with brass cap marked: From which new bearing trees. T6S R44E A white fir, 7 ins. diam., bears S59°W, 75 lks. dist., S34 mkd. 1/4 S3 BT. A white fir, 15 ins. diam., bears N80°W, 108 lks. dist., mkd. 1/4 S34 BT." Description of corner evidence found:

Found no trace of record BLM brass cap corner. Found an 8" Fir with grown over blaze. Measured N59°E, 49.5 ft. From here a 16" Fir bears N77°W, 70.0 ft. with partially grown over blazes. These are the 1974 BLM bearing trees. A 24" Fir with grown over blaze bears N18°E, 34.0 ft. A 36" stump bears S89°E, 46.5 ft. These are the original G. L. O. bearing trees.

Description of monument and accessories I established to perpetuate the original location of this corner:

At measured point set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 22" in the ground and mound of stone around

to cap.

Painted blazes red and 6" red band around. Bearing trees have 54-3s and 54-4s. Placed 54-4 on a steel fence post 5' east of the corner.
