## History of original corner establishment:

Corner originally set by Barry B. Barbour, LS 1051, during survey filed with the Baker County Surveyor, file no. 7-44-78 said survey subsequently CANCELLED.

Record states:

At surveyed point set 2%" x 30" aluminum pipe and cap, 14 ins. in the ground and mound of stone around to cap.

From which:

A pine, 14 ins. diam., bears S. 70° E., 28.7 ft. dist., scribed C/S/NW 1/64 S34 BT. A pine, 12 ins. diam., bears N. 40° W., 54.0 ft. dist., scribed C/S/NW 1/64 S34 BT.

Both bearing trees have washers stamped PLS 1051.

Corner reestablished by Rick E. Tawney, et al, under Group No. 1554, approved April 21, 1992.

Record states:


Set a stainless steel post, 28 ins. long, 2% ins. diam., 10 ins. in the ground, to solid rack, in mound of stone, 3 ft. base to top, with brass cap.

From which bearing trees mkd. by Barbour

A pine, 13 ins. diam., bears S. 62½° E., 25½ lks. dist., with visible scribe on partially healed

A pine, 12 ins. diam., bears N. 45½° W., 90 lks. dist., with visible scribe on partially healed blaze.

Aluminum cap stamped by Barbour, PLS 1051, bears N. 82°46'00" W., 0.060 chs. dist.



True point for the C-S-NW 1/64 sec. cor. of sec. 34 is located in a pond, where it is impractical to establish a permanent monument.

Found a 2½ ins. diam. steel post with 3¼ ins. diam. brass cap, loose, projecting 18 ins. above ground, with 3 ft. diam. stone mound, mkd. as shown.

From the recovered monument I find the bearing trees mkd. by Barbour

A pine, 13 ins. diam., alive & sick, bears S. 66¼° E., 20.5 ft. dist., with visible scribe on open blaze. (S. 62½° E., 25½ lks., Tawney)
A pine snag, bears N. 43° W., 56.4 ft. dist., with visible scribe on open blaze. (N. 45½° W., 90 lks., Tawney)

Found Barbour cap N. 823/4° W., 4.0 ft. from recovered monument.

## Description of monument and accessories I established to perpetuate original location of this corner:

New accessories

A chiseled XBO, on top of 2' x 3' x 1' boulder outcrop, bears S. 2° E., 36.8 ft. dist. A chiseled X, in westerly face of 2' x 3' x 1' boulder outcrop, bears N. 14° W., 29.8 ft. dist.

Rebuild rock mound.

Set guard post 5 ft. from recovered monument with Land Survey Monument (54-9) sign.




All bearing trees are painted with red bands, and have Bearing Tree (54-3) and Land Survey Monument (54-9) signs attached.
