A pine, 11 ins. diam., bears S. 80° E., 33.1 ft. dist., scribed C1/4 S34 BT. A pine, 15 ins. diam., bears N. 1° W., 26.8 ft. dist., scribed C1/4 S34 BT.

Both bearing trees have washers stamped PLS 1051.

Corner reestablished by Rick E. Tawney, et al, under Group No. 1554, approved April 21, 1992.

Set a stainless steel post, 28 ins. long, 2½ ins. diam., 16 ins. in the ground, to solid rock, and in a mound of stone, 21/2 ft. base to top, with brass cap.

A pine, 11 ins. diam., bears S. 82½° E., 45½ lks. dist., with visible scribe on partially healed blaze. A pine, 16 ins. diam., bears N. 61/2° W., 42 lks. dist., with visible scribe on partially healed blaze.

Aluminum cap stamped by Barbour, PLS 1051, bears N. 70°00'00" W., 0.050 chs. dist.



Found a 2½ ins. diam. steel pipe with a 3½ ins. diam. brass cap, mkd. as shown, firmly set, projecting 4 ins. above ground, with rock collar.

From the recovered monument I find the bearing trees mkd. by Barbour

A pine, 14 ins. diam., alive & healthy, bears S. 82% E., 30.0 ft. dist., with visible scribe on open blaze.

A pine, 20 ins. diam., alive & healthy, bears N. 6½° W., 27.7 ft. dist., with visible scribe on open blaze.

Found guard post 5 ft. East of recovered monument with Land Survey Monument (54-9) sign.

Found Barbour cap N. 70° W., 3.3 ft. from recovered monument.

Description of monument and accessories I established to perpetuate original location of this corner:

A chiseled XBO, in southerly face of 7' x 3' x 3' boulder outcrop, bears N. 48° E., 49.3 ft. dist.

New bearing tree

A pine, 17 ins. diam., bears S. 36° W., 49.0 ft. dist., mkd. C1/4 S34 BT, with washer in side center.




