

THE PURPOSE OF THIS SURVEY IS TO PERFORM A PROPERTY LINE ADJUSTMENT BETWEEN TAX LOT 700 OF MAP 07S 44E OWNED BY HEER, ET AL AND TAX LOT 100 OF MAP 07S 44E, NATIONAL FOREST SYSTEM LANDS ADMINISTERED BY THE U.S. DEPARTMENT OF AGRICULTURE, FOREST SERVICE. NATIONAL FOREST SYSTEM LANDS WERE ENCROACHED UPON BY IMPROVEMENTS CONSTRUCTED BY HEER, ET AL AND THEIR PREDECESSORS. THE ENCROACHMENT WILL BE RESOLVED UNDER THE AUTHORITY OF THE SMALL TRACTS ACT, PUBLIC LAW 97-465. THE CASE NUMBER IS 061617. THE TOTAL ACREAGE OF THE PARCEL IS 1.79 ACRES.

THE RIGHT-OF-WAY SHOWN HEREON IS RESERVED BY U.S. FOREST SERVICE RIGHT-OF-WAY RESERVATION, BUREAU OF LAND MANAGEMENT SERIAL NO. OR68578, WITH ACTION DATE OF SEPTEMBER 11, 2015 AND IS SHOWN AS A REPRESENTATION OF THE EXISTING ROADWAY OF FOREST SERVICE DEVELOPMENTAL ROAD 7735-490. TIES TO THE BEGINNING AND TERMINUS OF THE EXISTING CENTERLINE OF ROAD WERE MADE USING TERRESTRIAL AND RESOURCE GRADE GPS MEASUREMENTS FROM THE WEST SIXTEENTH CORNER OF SECTIONS 25 AND 36. THE RIGHT-OF-WAY IS 33 FEET WIDE, 16.5 FEET EACH SIDE OF CENTERLINE AND IT EXTENDS FROM AND TERMINATES AT THE TRUE PRE-ADJUSTED PROPERTY LINE. THE ROAD RIGHT-OF-WAY CONTAINS 0.21 ACRES MORE OR LESS.

THE BEARINGS ARE BASED ON THE SECTION LINE BETWEEN THE WEST SIXTEENTH CORNER AND THE QUARTER CORNER OF SECTIONS 25 AND 36, BEING N 89° 58' 41" E AS SHOWN ON BAKER COUNTY SURVEY NO. 7-44-264. THE NEW PROPERTY LINE IS MARKED WITH ALUMINUM POSTS AND NATIONAL FOREST PROPERTY BOUNDARY SIGNS.
