
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner originally established by W.B. Barr under GLO contract No 443, dated May 29, 1882. Surveyor General record states: Set basalt rock 15x8x5 ins 10 inches in ground for corner to Sec 1,2,35,36 marked with 1 notch in the East and 5 notches on the West sides, from which a fir 10 in diam bears N65°E 25 lks dist marked T6SR45ES36BT a fir 8 in diam bears N45°W 34 lks dist marked T6SR45ES35BT a fir 16 in diam bears S650W 50 1ks dist



marked T7SR45ES28T a tamarack 14 in diam bears S27°E 19 1ks dist marked T7SR45ES1BT. Corner remonumented by Lester A. Fischer for the BLM under U.S. Survey Group No. 350 dated August 22, 1974. Official record states in part: The corner position was determined from the record bearing and distance from the remains of the Southeast and Southwest BTs. Set an iron post with brass cap from which: A subalpine fir 8 in diam bears N83°E 47 1ks dist marked T6S R45E S36 BT A white fir 8 in diam bears S22°E 23 1ks dist marked T7S R45E S1 BT A lodgepole pine 8 in diam bears N78°W 11 1ks No other trees available. dist marked T6S R45E S35 BT.

Found all BTs taken by the BLM live and vigorous
