History of original corner establishment:

Corner was originally established under G. L. O. contract number 443, by W. B. Barr, on August 5, 1882. Surveyor General's notes state: "Set iron rock 14 X 12 X 5 ins. 10 ins. in the ground for 1/4 sec. cor. From which a pine 9 ins. diam. bears N78°W, 47 lks. dist. marked 1/4 S BT. A pine 9 ins. diam. bears S16°W, 40 lks. dist. marked 1/4 S

Description of corner evidence found:

No trace of record stone or bearing trees could be found.

Corner falls on southeast slope, about 150 ft. south of an east-west ridge.

The corner was set by me in 1978 and was re-surveyed in 1982. The corner was found as described in R6-7100-57 filed with the County Surveyor in 1978.

Description of monument and accessories I established to perpetuate the original location of this corner:

The corner was moved 1.05 ft. south in 1982 to fit the new survey measurements. At surveyed point set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 25" in the ground and mound of stone around to cap.
