### NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO DEFINE THE BOUNDARY OF THAT CERTAIN PARCEL OF LAND DESCRIBED IN DEED RECORDED JUNE 30, 2020, IN INSTRUMENT No. 20 26 0278, BAKER COUNTY RECORDS, SITUATED IN THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 7 SOUTH, RANGE 45 EAST, WILLAMETTE MERIDIAN, BAKER COUNTY, OREGON, AND TO CREATE TWO NEW PARCELS, AT THE REQUEST OF DONNA DRAPER.

MONUMENTS WERE FOUND AND HELD AT THE SOUTHEAST CORNER AND THE SOUTH ONE QUARTER CORNER OF SAID SECTION 36. MONUMENTS WERE ALSO FOUND AND HELD ALONG THE WEST LINE OF SAID SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER, AS SHOWN. THE ORIGINAL DEED CALLS ARE CARDINAL AND EVEN RODS. THE SOUTHEAST CORNER OF SAID PARCEL WAS HELD AT DEED DISTANCE AND THE EAST LINE THEREOF WAS HELD PERPENDICULAR TO THE SOUTH LINE OF SAID SECTION 36.

MONUMENTS WERE SET AT THE EXTERIOR BOUNDARY CORNERS AND TO DEFINE THE NEW PARCELS, AS SHOWN HEREON.
