- A 52 inch sawed stump bears North, 50.2 ft (76 lks) with no visible scribes for official record line tree

At position established from original accessary evidence found a stone 12x8x7 inches firmly set but could not identify any chisle work.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 2½ inch brass cap on a 2 inch iron pipe 31 ins long 28 ins in the ground with a surrounding rock mound and a 6 ft steel fence post 4 ft North with a sign 54-4 attached. Buried stone alongside brass cap monument.
