Surveyor General's notes state: "Set a granite boulder 16 X 12 X 10 ins. 10 ins. in the grnd., for 1/4 sec. cor, marked 1/4S on the W. face, from which a pine tree 16 ins. in diam. brs. N10°E, 50 lks. dist. marked 1/4S15 BT, and a pine 8 ins. in diam. brs. N6°W, 75 lks. dist. marked 1/4 S16 BT. (Pit Imp.)."

Description of corner evidence found:

Found 11 X 11 X 7 inch stone, set in a mound of stone, clearly marked 1/4S. Found 18" pine stump and fallen tree with open blaze, N6°W, 33.0 ft. Found a live 33" pine, N10°E, 49.5 ft. with blazes and visible scribing. Note: Distances to bearing trees found in the field, indicate a recording error in original notes. The stone was accepted as being correct.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the center of the above point, set 2 1/2" X 30" galvanized

pipe and brass cap marked: Set pipe 24" in the ground and mound S16 S15

A 20" pine bears NO2°W, 66.3 ft. scribed 1/4 S16 BT. Painted blazes red and 6" red band around. Placed 54-3, 54-4 and brass washer stamped PLS 1051 on the BT. Placed 54-2 and 54-4 on a steel fence post 5' south and 54-2 on a steel fence post 5' north of the corner.
