History of original corner establishment:

Corner was originally established under G. L. O. contract Number 707, by Williard B. Blakeslee on June 11, 1901. Surveyor General's notes state: "Falls on solid rock in place 30x24x24 ins., above grnd. I cut a cross (+) at the exact point and marked 1/45 on the W. face for 1/4 sec. cor. from which a pine tree 32 ins. in diam., brs, N 8°E, 32 lks. dist. marked 1/4S22 BT. and a pine 21 ins. in diam. brs. N 40°W., 33 lks. dist. marked 1/4821 BT. (Pits Imp.)"

Description of corner evidence found:

Found solid rock, about 33ft. north of west bearing drain, dimly marked 1/4S on west face, from which a down and rotten pine bears N480E. 23 ft. with possible parts of blazes. No scribing found. No trace of NF BT could be found. Removed $36" \times 24" \times 22"$ rock and marked center of stone.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the center of the above point, set 2 1/2" X 30" galvanized pipe and brass cap marked: Set Pipe 18" in the ground and mound of stone around to cap. Removed marked stone from area. from which by magnetic declination of $N20^{\circ}E$:

A 21" pine bears S89°E, 66.9 ft. scribed 1/4S22 BT. A 21" pine bears N50°W, 49.1 ft. scribed 1/4S21 BT.

Painted blazes red and 6" red band around. Placed 54-3s, 54-4s, and brass washers stamped PLS 1051 on the BTs. Placed 54-2 and 54-4 on a steel fence post 5' north and placed 54-2 on a steel fence post 5' east of the corner.
