**ORIGINAL DESCRIPTION:** Set an iron post, 3 ft. long, 2 ins dia., 27 ins. in the ground, for cor. of secs. 24 and 25 only, with brass cap marked (diagram shown) from which

A balsam, 6 ins. dia., bears S.  $2\frac{1}{2}$ ° W., 45 lks. dist., marked T 8 S R 36 E S 25 BT. A black pine, 7 ins. dia., bears N. 60° W.,  $6\frac{1}{2}$  lks. dist., marked T 8 S R 36 E S 24 BT.

HANLEY'S DESCRIPTION: A brass cap on an iron pipe marked as shown in corner diagram.

An 8" snag bears N 60° W.,  $6\frac{1}{2}$  lks. dist with visible scribes.

A fir 12" diam. bears S  $2\frac{1}{2}$  ° W., 45 lks. dist. with healed blaze.

Improved surrounding rock mound around corner monument and set a 6 foot steel fence post alongside with a sign 54-9 attached.

New bearing tree:

A spruce 15 inches diam. bears N 72° W., 7.5 ft. dist. marked T 8 S R 36 E S 24 BT and has a brass washer marked PLS 1639 nailed flush with BT blaze.

**EVIDENCE FOUND:** Found 2" iron pipe with  $2\frac{1}{2}$ " brass cap, marked as shown below, showing 4" above the top of a 2.5 ft. diameter mound of stone, with bent steel fence post laying alongside, smashed by falling snags.

From which, I found the following bearing trees:

- ► A fir snag, 12" dbh, bears S.2½°W., 29.7 ft., with healed single blaze (GLO BT)
- ► An Engelmann spruce, 23" dbh, bears N.75°W., 7.5 ft., with healed double blaze (Hanley BT)

### DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

I accept the position of the found monument for the corner.

#### From which, I SCRIBE A NEW BEARING TREE:

► An Engelmann spruce, 18" dbh, bears S.57°W., 15.20 ft. marked *T8SR36ES25* in upper blaze, and *BT* in lower blaze.

# Also from which, I SET NEW REFERENCE POINTS:

- ► A 5/8"x 24" iron pin, bears N.25°E., 8.72 ft., with attached 2" aluminum cap marked *RP 1 2023 PLS 69454*
- ► A 5/8"x 24" iron pin, bears S.45°E., 14.44 ft., with attached 2" aluminum cap marked *RP 2 2023 PLS 69454*

CORNER MONUMENT MARKED:



Painted a 6 inch red band around the bearing trees, and also painted the blazes red. Attached USFS 54-3 and 54-9 signs to BT's. Used a staff compass with 14° East declination to measure bearings to accessories. Used a steel tape to measure distances to accessories. Distance to new bearing tree was measured to a 60d nail driven in the side-center at the root crown of the tree, with an attached  $1\frac{1}{2}$ " aluminum washer stamped PLS 69454. I straightened and reset Hanley's steel fence post South, 2 ft. from the monument, and attached a USFS 54-9 sign. See associated Map of Survey dated October 17, 2023 for survey-related information.
