CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

The corner was originally established by Arthur Philbrick under Mineral Survey No. 477, during the survey of June and July 1902. The original notes state that at the corner a scribed black pine post 4 long by 4 sq. was set 12 in the ground and surrounded with a mound of earth from which:

A 6" black pine bears N71°47'E-7.68'. A 4" black pine bears N31°05'W-12.08'. Both marked B.T.K.2-477.

Description of corner evidence found:

Found a mound of earth and the remains of the rotted post at ground level and the original post lying beside the mound. From the mound:

A 10" live lodgepole pine bears N73 $\frac{1}{2}$ °E-7.9' with scribing visible on partly healed blaze (original bearing tree).

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a $2\frac{1}{2}$ " by 30" aluminum pipe with a $2\frac{1}{2}$ " aluminum cap 24" in the ground and surrounded with a mound of earth and stone. Placed the remains of the original post on the mound. From the monument:

A 7" engleman spruce bears S51½°W-21.2' scribed 2-K-477 BT.

The new bearing tree has a brass washer stamped PLS 1106 nailed to face of blaze. Attached signs 54-3 and 54-9 to each bearing tree and painted face of blaze and a 6" red band around each bearing tree. Set steel fence posts on National Forest Boundary NE and SE of corner and attached sign 54-9 to one post and sign 54-2 to both posts.

Cap is marked:

Used steel tape and staff compass with 20° E declination, measured to the center of the bearing trees.

This corner was remonumented on August 9, 1985.
