I found a stone mound with remains of scribed wood post on surface with scribing of "H 3 485". Found a 6"x4"x5" rotted pointed remnant of post 19" below surface. ACCESSORIES FOUND:

22" dia. Grand Fir bears N62E, 14.2 ft. with healed blaze. (did not open) 21" dia. Grand Fir bears N77E, 15.9 ft. with healed blaze. (did not open)

Description of monument and accessories I established to perpetuate the original location of this corner:

CORNER WORK DONE ON 6/19/90

At the position of the pointed post remnant, set a 2.5" dia. by 30" long C. aluminum pipe with a 2.5" dia. aluminum cap. The pipe is set 19" in the ground on bedrock at point of post remains. Mounded earth and stone to i" of top. Cap is marked
