## CERTIFIED RECORD OF LAND CORNER MONUMENTATION


## History of original corner establishment:

Corner originally established by Arthur Philbrick under Mineral Survey No.481 and dated July 11, 1902.

Original notes state:

A black pine post, 4 ft.long, 4 ins.square, set 12 ins. in the ground, with mound of earth, scribed B.B.l-R.F. 5-481, whence

A red fir,12 ins.diam,bears S77°30'W, 54.57 ft. A red fir,4 ft.diam.bears S24°W, 42.34 ft.,each scribed B.T.B.B.1-R.F.5-481.



Cor.6 RED FOX Cor.1 BELL BAKER

Corner amended by Arthur B.Browne under Mineral Survey No.481 and dated May 14,1904. Original notes state: Scribing on post changed to read R.F.6-481, scribing on two bearing trees, as given in notes of original survey, also changed to read, B.T.R.F.6-481.

## Description of corner evidence found:

No trace of original pine post.

A 40" dia. douglas fir stump brs  $S22^{O}W$  44.3' to centerline (42.34' to face) with X and nail visible.(Original BT) A 31" dia.douglas fir stump brs  $S78\frac{1}{2}^{O}W$  55.1' to centerline (54.57' to face) with back cast and nail.(Original BT)

## Description of monument and accessories I established to perpetuate the original location of this corner:

Corner position reset by distance/distance intersection from original bearing tree faces, using record distances...

Set  $2\frac{1}{2}$ " x 30" aluminum pipe with  $2\frac{1}{2}$ " aluminum cap 24" in ground and surrounded with a mound of earth and stone. Cap marked as shown in corner diagram.

New bearing tree and bearing object established: A 22" douglas fir brs  $S62^{\frac{1}{2}}$ E, 85.8' scribed 1-BB-481/6RF-481-AMD BT. A 28" x 14" x 16" out of ground stone in place bears N74 3/4°E, 5.8', marked "XBO". Distance measured to "X".

New bearing tree has a brass washer stamped PLS 1106 nailed to face of blaze. Attached sign 54-3 & 54-9 to each BT & painted face of blaze & 6" red band around each BT. Set steel fence post on National Forest Boundary SW of corner with sign 54-2 & 54-9 attached.

Compass declination 180 East.

I hereby certify that the above corner was properly re-established by me to U.S.F.S. standards on September 10, 1992.
