

ORIGINAL DESCRIPTION: To corner No. 1, identical with old location S.E. Corner. Set a post $4\frac{1}{2}$ feet long 4 inches square, 12 inches in the ground, with mound of stone, marked Cor. 1 T.Q.C. from which A tamarack 16 inches dia, blazed and marked Cor. 1 T.Q.C. (B.T.) bears N.87°W. 11 feet distant. A Fir 12 inches dia, blazed and marked (B.T.) bears S.15°30'W. 36 feet distant.

MINERAL SURVEY 256 DESCRIPTION: Beginning at Corner No. 1, identical with Cor. 1 of location and Cor. 1 Tacoma Cons. Claim M.S. No. 252, previously described, mark it on East face Cor. No. 1 C.P.C. M.S. No. 256, from which Mineral Monument No. 1, in T.8S., Rge 37 E. W.M. bears S.17°30'W. 2425 feet distant.



EVIDENCE FOUND: Found Mitchell's unrecorded monument, which is a $1\frac{1}{2}$ " galvanized iron pipe with a $2\frac{1}{2}$ " brass cap, marked as shown, projecting 3" above ground in a 3 ft. diameter mound of stone. From which, I also found the following bearing trees:

- ► A white fir stump, 10" diam, with rotted log alongside, bears S.09°W., 20.8 ft. (Mitchell BT).
- ► A dead and down (wind-thrown) white fir, 32" diam, bears S.12°W., 38 ft., with healed blaze. I removed the overgrowth to reveal a large blaze with scribing *COR 1* and *MS N 252 B* legible amongst other fragmentary scribe marks. Bearing and distance was measured to approximate center of root wad hole. (Original BT).
- ► A western larch, 23" dbh, bears N.86°W., 10.65 ft., with partially opened blaze with visible scribing *MS N* and other fragmentary scribe marks. Distance was measured to face of blaze. (Original BT).


DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED: I accept Mitchell's brass cap monument as a faithful and accurate perpetuation of the original corner, being harmoniously related to the original accessory evidence, and also to other found accepted corners of Mineral Survey 256. Cap is marked as shown.

From which, I SCRIBE A NEW BEARING TREE:

▶ A western larch, 10.5" dbh, bears N.55°23'E., 38.4 ft. marked X in upper blaze, and BT in lower blaze. Distance measured to a Mag Spike driven in the side-center-right at the root crown, with an attached 1½" aluminum washer stamped PLS 69454.

Painted a 6 inch red band around the live bearing trees, and also painted blazes red, and attached new USFS 54-3 and 54-9 signs. Distances measured with an EDM device. Used RTK GPS to measure bearings. Bearings are geodetic, based on GPS observation taken at the corner. Set an aluminum guard post N.15°W., 5 ft., with USFS 54-2 sign attached, and another aluminum guard post S.27°W., 5.6 ft., with USFS 54-2 and 54-9 signs attached.
