

ORIGINAL DESCRIPTION: To post and mound of rocks marked Columbia Mine Sta No. 2 Sur No. 176.

MS 204 DESCRIPTION: Commencing at a pine post 5 ft. long and 6 inches in dia., set 18 inches in the ground with mound of Rocks around same. Which post is Station No. 2 in the official Survey of the Columbia Quartz Claim. Said post being marked "Appomattox Claim Sta. No. 1. Sur. No. 204" and from this post a Mineral Locating Monument, built of Rocks about 5x5 feet & 6 feet high located on the Ridge or divide between Cracker Creek and Fruit Creek. This monument being the one to which the Eureka, Excelsior, and Columbia Quartz Claims are connected. bears N.48°E. 1747 feet distant.

EVIDENCE FOUND: Found a 2 ft. diameter mound of stone with a 2" diameter hole in the center where Mitchell's monument was set. I found no trace of Mitchell's pipe with brass cap. From which:

- ► A white fir, 27" dbh, bears S.33°30'E., 32.0 ft. with fully-healed single blaze (Mitchell BT)
- ► A 1 ¾" iron pipe, threaded on top, firmly set, projecting 2.5 ft. above ground, bears S.10°W., 7.53 ft. (origin and significance unknown)
- ► The rotten remains of a ponderosa pine stump, uprooted, with portion of blaze and partial scribing 66 BT visible. The center of the root wad hole bears S.27°W., 11.5 ft.+/- (MS 366 BT)
- ► A lodgepole pine, 8.5" dbh, bears N.58°30'W., 24.1 ft. with fully-healed single blaze (Mitchell BT)

I accept the position of the hole in the center of the mound of stone as the best available evidence of the original corner, being harmoniously related to the found accessory evidence and other found accepted corners in the area.

DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED: At the corner point, I set a standard USFS $2\frac{1}{2}$ " x 30" aluminum pipe with attached $3\frac{1}{4}$ " aluminum cap, 28" in the ground. Built a 2.5 ft. diameter mound of stone around the monument to top of cap. Cap is marked as shown below.

CORNER MONUMENT MARKED:

Placed a plastic-encased magnet at the base of the aluminum pipe. Painted a 6 inch red band around each bearing tree, and also painted the healed blazes red, and attached new USFS 54-3 and 54-9 signs. Distances measured with a steel tape to a Mag Spike driven in the side-center at the root crown of each tree, with an attached $1\,\%$ " aluminum washer stamped PLS 69454. Used RTK GPS to measure bearings. Bearings are geodetic, based on GPS observation taken at the corner. See associated Map of Survey dated August 20, 2025 for survey-related information.
